SUBJECT: AN ORDINANCE TO CORRECT A TYPOGRAPHICAL ERROR IN ORDINANCE NO. 2004-06-078 ENTITLED "AN ORDINANCE FIXING A TIME AND PLACE FOR A PUBLIC HEARING IN CONNECTION WITH A PROPOSED SUPPLEMENT AND AMENDMENT TO THE REDEVELOPMENT PLAN AND RELATED REDEVELOPMENT PROJECTS FOR THE DOWNTOWN URBANA TAX INCREMENT REDEVELOPMENT PROJECT AREA"

Description

The purpose of the attached Council Resolution (Attachment A) is to amend Council Ordinance 2004-06-078, which set the time and place of a public hearing regarding an Amendment to the original Downtown TIF 1 Plan that will expire on December 15, 2004. This Plan Amendment would extend the Downtown TIF 1 Plan for an additional 12 years (until 2016). The Plan Amendment would also update redevelopment projects to be undertaken in the Redevelopment Project Area under the Downtown TIF 1 Plan.

Background

Ordinance No 2004-06-078 correctly set the date of the public hearing for September 7, 2004; however it incorrectly set the time and day as <u>7:30 p.m.</u>, on a <u>Monday</u>. To correct this typographical error the hearing announcement should read as follows: "The time, date and place of such public hearing is herby fixed to be at <u>7:15 p.m.</u> on <u>Tuesday</u>, September 7, 2004, at the Municipal Building, 400 S. Vine Street Urbana, Illinois".

All other published and mailed notices required for this hearing under the Illinois Redevelopment Act are correct and/or have been corrected.

Recommendation

Staff recommends that the Council amend the time and day in the hearing as stated in the attached ordinance (Attachment A).
