URBANA CITY COUNCIL MEETING December 6, 2004

The City Council of the City of Urbana, Illinois met in regular session at 7:30 p.m., Monday, December 6, 2004 in the Urbana City Council Chambers at 400 South Vine Street.

There being a quorum, Mayor Satterthwaite called the meeting to order at 7:30 p.m.

Present at the meeting were Members of the Council: Chynoweth, Hayes, Patt, Whelan, and Wyman –5; absent: none.

Also present were staff members: Police Chief Eddie Adair, Comptroller Ron Eldridge, Public Works Director Bill Gray, Grants Management Manager Bob Grewe, City Attorney Steve Holz, Planning Division Manager Rob Kowalski, Fire Chief Rex Mundt, Economic Development Division Manager John Regetz, Community Development Manager Libby Tyler, and Chief Administrative Officer Bruce Walden.

MINUTES OF PREVIOUS MEETING

Alderman Hayes moved to approve the minutes of the November 15, 2004 minutes. The motion was seconded by Alderwoman Wyman and carried by a voice vote.

ADDITIONS TO THE AGENDA

There were none.

PETITIONS AND COMMUNICATIONS

Gerald Knight, 405 Beringer Circle, was present but did not address the Council, in opposition to the Special Use Permit for Aldi.

Venkatesh Yekkirala, 2924 Rutherford, addressed the Council in opposition to the Special Use Permit for Aldi due to his concern regarding the noise that would be generated by Aldi's equipment.

Marianne Armstrong, 411 Beringer Circle addressed the Council in support of the Special Use Permit for Aldi and the break in the wall on Rutherford Street.

Gary Durack, 2910 Rutherford, and Warren Rittenhouse, 2918 Rutherford, addressed the Council in support of the Special Use Permit for Aldi with no break in the wall on Rutherford.

Ed Perkins, 2917 Rutherford, stated his opposition and suggested that the zoning be changed.

The motion was seconded by Alderwoman Patt. Chief Administrative Officer Bruce Walden presented a few minor changes to the ordinance. Following debate, the motion carried 5-0 by roll call vote. Alderwoman Wyman moved to approve Ordinance No. 2004-11
148: An Ordinance Authorizing the Mayor to Execute an Agreement With the New Lincoln Square, LLC, (to Provide Parking Facilities). The motion was seconded by Alderwoman Patt. Following debate, the motion carried 5-0 by roll call vote. Voting aye were Members of the Council: Chynoweth, Hayes, Patt, Whelan, and Wyman – 5; voting nay: none.

Alderwoman Wyman moved to approve Ordinance No. 2004-07-087: An Ordinance Approving and Authorizing the Execution of a Second Cooperative

Agreement (Urbana Free Library). The motion was seconded by Alderwoman

Chynoweth. Following debate, the motion carried 5-0 by roll call vote. Voting aye were

Members of the Council: Chynoweth, Hayes, Patt, Whelan, and Wyman – 5; voting nay: none.

Alderwoman Wyman moved to adopt Resolution No. 2004-11-026R: A

Resolution Approving and Authorizing the Execution of an Intergovernmental

Agreement with the Champaign-Urbana Mass Transit District (Cooperation in

Annexations). The motion was seconded by Alderwoman Patt and carried by a voice vote.

Alderwoman Wyman moved to adopt Resolution No. 2004-11-027R: A

Resolution Approving and Authorizing the Execution of a Letter of Understanding

with the Village of Savoy, The Board of Trustees of the University of Illinois, the

County of Champaign and Urbana Township (Curtis Road: First Street to Race

Street). The motion was seconded by Alderwoman Patt and carried by a voice vote.

Alderperson Wyman moved to adopt Resolution No. 2004-11-029R: A

Resolution to Include Compensation Paid Under I.R.C. Section 125 As I.M.R.F.

Earnings). The motion was seconded by Alderman Hayes and carried by a voice vote.

Alderwoman Wyman moved to approve Ordinance No. 2004-11-150:

Annual Tax Levy Ordinance of the City of Urbana, Illinois for the Year Beginning

July 1, 2004 and Ending June 30, 2005. The motion was seconded by Alderman Patt.

Comptroller Ron Eldridge explained that he had a call from the Cunningham Township Assessor Joanne Chester stating that there was an error in the office of the Supervisor of Assessments. The estimate Mr. Eldridge had originally received on how much the assessed value would raise had been understated by about 1 ½%. The process starts with the Truth in Taxation Resolution which sets the

maximum amount that can be levied. The maximum amount was at the original amount received. If the ordinance that was passed stayed with the original numbers instead of having the same rate of \$1.31, the rate would go down to \$1.29.

The best option is to go ahead and pass the original tax levy ordinance from last week, as well as the abatement ordinance and the resolution. That will secure that that is done and can't be challenged.

If Council desires, there is enough time to pass a new truth in taxation resolution at the higher numbers.

An Ordinance Abating Tax Levy for \$5.705 Million General Obligation Bonds,

Series 1994. The motion was seconded by Alderwoman Patt and carried 5-0 by roll call vote. Voting aye were Members of the Council: Chynoweth, Hayes, Patt, Wyman, and Whelan – 5; voting nay: none.

Alderwoman Wyman moved to adopt Resolution No. 2004-11-028R: A

Resolution Directing the Champaign County Clerk to Abate the Tax Levy for the

General Corporate Purpose for the Year Beginning July 1, 2004 and Ending June

30, 2005. The motion was seconded by Alderwoman Patt and carried by a voice vote.

Alderwoman Wyman moved to adopt Resolution No. 2004-12-030R: A

Resolution Determining the Amounts of Money Necessary to be Raised by the

Tax Levy (2004 – Corrected). The motion was seconded by Alderman Hayes and carried by a voice vote.

Grants Management Manager Bob Grewe presented staff report on

Resolution No. 2004-12-031R: A Resolution Authorizing the Mayor to Execute a

Certification of Consistency for the Housing Authority of Champaign County Five
Year Plan FY 2005-2009 and the Annual Plan Fiscal Year 2005. Matthew Hogan and

Ed Bland, representing the Housing Authority of Champaign County, were present to

answer any questions from Council Members.

In order for the Housing Authority of Champaign County to submit their 2005 Annual Plan, the City of Urbana must execute a Certification of Consistency indicating that the Plan is consistent with the City of Urbana and Urbana HOME Consortium Consolidated Plan. This is an annual request.

Following debate, Alderwoman Patt moved to forward Resolution No.

2004-12-031R: A Resolution Authorizing the Mayor to Execute a Certification of

Consistency for the Housing Authority of Champaign County Five-Year Plan FY

2005-2009 and the Annual Plan Fiscal Year 2005 to the Special City Council Meeting
on December 13, 2004 with the request that the statement in italics on page 1 of the
handout be changed to state "Affordable housing for families with incomes below 30%
of area median income". The motion was seconded by Alderwoman Wyman.

Alderwoman Wyman requested a friendly amendment that would include a check mark
updating the mission of the Public Housing Authority including information on the overall
number of families with disabilities under Housing Needs in the Jurisdiction by Family
Type, which is located on page 7 of the 5 year plan. The friendly amendment was
accepted by the mover. Following further debate, the motion carried 4-1 by roll call
vote. Voting aye were Members of the Council: Chynoweth, Hayes, Patt, and Wyman

– 4; voting nay: Whelan – 1.

Planning Department Manager Rob Kowalski presented staff report on

Ordinance No. 2004-12-152: An Ordinance Approving a Special Use Permit

(Request to establish a grocery store in the B-1, Neighborhood Business Zoning

District – Plan Case No. 1909-SU-04). Aldi, Inc. is requesting approval of a Special

Use Permit to establish a grocery store at the northwest corner of U.S. Route 150 and Illinois Route 130. Mr. Kowalski reviewed the Site Development plans.

Following extensive debate, Alderwoman Chynoweth moved to approve

Ordinance No. 2004-12-152: An Ordinance Approving a Special Use Permit (Request to establish a grocery store in the B-1, Neighborhood Business Zoning District – Plan Case No. 1909-SU-04) the following:

- A wall
- An eight foot break in the wall
- The location and design of the sidewalk will be approved by City Staff
- The developer will install rooftop screen panels as specified in the site plan and to comply with State requirements
- The construction of the walls required shall be completed prior to the opening of the store
- And to include in the whereas statements that the original developer of Beringer Commons Subdivision has agreed to install a sidewalk at the developers expense along the north side of U.S. Route 150 from Beringer Circle to the Aldi site
- Whereas a lack of the continuous sidewalk along U.S. 150 to access the proposed is detrimental to public safety and welfare, the original Beringer Commons developers agree to work with the City of Urbana and IDOT to determine the appropriate location of the sidewalk and agree to install the sidewalk within two years.

Following debate, Alderwoman Patt moved to amend the motion to

remove the eight-foot wide break in the wall and the location and the design of the

sidewalk shall be approved by City Staff and to put in there shall be no vehicular or

pedestrian access from Rutherford drive. The motion was seconded by Alderwoman

Wyman. Following extensive debate, the motion carried 3-2 by roll call vote. Voting

aye were Members of the Council: Hayes, Patt, and Wyman – 3; voting nay:

Chynoweth and Whelan – 2.

Following debate, the motion carried 4-1 by roll call vote. Voting aye were

Members of the Council: Chynoweth, Hayes, Patt, and Wyman – 4; voting nay:

Whelan – 1.
