6. TRAFFIC COMMISSION ITEMS:

a. Ordinance No. 2004-12-153: An Ordinance Amending Schedule H of Section 23-93 of the Urbana Local Traffic Code Requiring Stop Signs at a Certain Intersection (McCullough Street at Griggs Street; Locust Street at Central Avenue)

William Gray (Public Works Director/City Engineer) presented the staff report.

 b. Ordinance No. 2004-12-154: An Ordinance Amending Schedule L of Section 23-187 of the Urbana Local Traffic Code Prohibiting Parking in Specified Places (Harding Drive)

7. SCOTTSWOOD DRAINAGE IMPROVEMENT UPDATE

Mr. Gray presented. (See attached.) Construction on this project is scheduled for spring of 2005 with an estimated cost of \$800,000 for Phase I. Partial funding will come from a \$350,000 grant from the Community Development Assistance Program, and the balance from Champaign County and a drainage district assessment levied by the St. Joseph Drainage District Commissioners. The Regional Plan Commission staff is administering this project.
