1. CALL TO ORDER AND ROLL CALL

There being a quorum, Chair Roberts called the meeting of the Committee Of The Whole to order at $7:31~\mathrm{p.m.}$

2. ADDITIONS TO THE AGENDA AND STAFF REPORT

There were no additions to the agenda.

Mayor Satterthwaite reported that Walgreen's had given a press release announcing their plans for development at the northeast corner of Five Points. They expect to break ground some time in April. This will be a 24-hour operation with a drive-thru pharmacy. It is a new development project and not relocation for the Walgreen's at Sunnycrest. It will remain open at that location. Bruce Walden (Chief Administrative Officer) indicated that he hopes to have an agreement for this development to Council within the next few weeks.

Mr. Walden reported on the agreement with AmerenIP to conduct an audit to locate problems with the system that can be improved. This is primarily for businesses in the area in order to see if there is a need for improvement to service reliability. Committee Member Input

Mayor Satterthwaite responded to inaccurate acquisitions that were made concerning his comments made in The News-Gazette about the Human Relations Ordinance. He is suggesting that the City review this ordinance and consider making it consistent with that of the City of Champaign and the policies of the Housing Authority of Champaign County.

Ms Patt commented on Mayor Satterthwaite's response and mentioned her recent trip to Springfield where she testified before the Illinois House Judiciary Committee against a piece of legislation whose sole purpose was to override the Urbana City Council and prevent them from enforcing the provisions of the Urbana Human Rights Ordinance that prohibits discrimination based on prior arrests or a conviction record. Ms Patt said that the Department of Corrections signed in against the Bill in agreement with her position, as did the Illinois Municipal League and a number of organizations advocating for the rights of the poor and housing rights. She also noted that HUD does not mandate the policy of the Housing Authority.
