AN ORDINANCE AMENDING SCHEDULE C OF SECTION 23-73 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING LEFT TURNS DURING CERTAIN HOURS ON CERTAIN STREETS

(Mathews Avenue at Springfield Avenue)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule C of Section 23-73, entitled "Obedience to No-Turn Signs" of Article VI of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street which shall be established as prohibiting left turns between certain hours of any day:

Street	Direction	Street	Days	Hours
Mathews Avenue	Northbound	Springfield Avenue	All	6:00 a.m to 6:00 p.m.

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

<u>Section 4</u>. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance

shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
