### 13. INFORMATION REGARDING MAILING/E-MAILING PACKET INFORMATION

It was the consensuses of the Committee to have staff investigate the purchase of some form of E-Gov package for the purpose of packet distribution to the Council. This package should: 1) provide the ability to get packets out earlier (allowing council members to ask and get answers to questions sooner); 2) save postage; 3) provide the ability to go to a secure site to make alterations; and 4) simplify.

Mr. Smyth will be the council representative working with staff on this project. No action was required of council at this time.

### 14. DISCUSSION: PARKLET ON NORTH GOODWIN AVENUE

Chair Smyth opened this item for discussion, noting that this issue had come to his attention from the Urbana Police Department because of some problems and complaints they are having there. There also appears to be some confusion about the ownership of this property. This is a vacant lot located at the southwest corner of North Goodwin Avenue and Fairview.

Mr. Lewis informed the Committee that there are problems at this location and he has received complaints from constituents in the area. Most of the complaints refer to disturbances by a group of young people. Residents would like to see the parklet removed, if possible.

 $\mbox{\rm Mr.}$  Walden indicated that staff would do a title search to see who owns the property.

Staff will report back to Committee. No action was taken at this time.
