RE: Ordinances from Traffic Commission

Attached are three ordinances for your approval from action taken by the Traffic Commission. Maps are attached showing the proposed ordinances.

The first ordinance which amends Schedule J is for the prohibition of parking at all times on the east and west sides of Lierman Avenue from Main Street to Hunter Lane. This was a two part action. The area between Washington Street and Hunter Lane was requested by the manager of the Woodstone Apartments where parking currently exists. The apartment complex has recently gone under a major renovation and additional off-street parking was installed to accommodate the cars parked on the street; therefore, there is not a great demand for the on-street parking. The parking restrictions will help with public safety in that area. The second area was Lierman Avenue from Main Street to Washington Street. This was needed due to the new concrete pavement being constructed now. The new pavement is not wide enough to allow parking on the street. All adjacent property owners have been notified of this action.

The second ordinance which amends Schedule J is for the prohibition of parking at all times in specific areas on Main Street from Central Avenue to Springfield Avenue. This ordinance will clarify where parking is restricted and where it is allowed in the area described above. Streetscape construction has recently been completed that included new curb and gutters and driveway pavements and as a result much of the existing yellow curbs and signs were removed. Currently several areas between driveways could potentially have vehicles park there and restrict visibility out of the driveways. All affected property owners have been notified and we are working with Firestone Service Center in particular to solve some remaining parking issues at that location.

The third ordinance which amends Schedule J is for the prohibition of parking at all times on the west side of Rutherford Drive from 681 feet east of North Beringer Circle to East Beringer Circle. This is required due to the street width of 25' not being wide enough to have parking on both sides. Residents of the area were polled to determine which side to keep parking and the east side was the choice.

The Traffic Commission has considered and recommends the attached ordinances.

ORDINANCE NO. 2005-08-119

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Main Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At all Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance Shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.


