C. PETITIONS AND COMMUNICATIONS

Burnell Dixon, 507 Crystal Lake Drive, addressed the Council concerning an incident with the Urbana Township Supervisor and staff, and read into record a letter he prepared. (See attached.)

Carol Ammons, 1108 N. Busey, representing C-U Citizens for Peace and Justice, addressed the Council on the topic of police conduct and concerns of residents about recent allegations against an Urbana police officer involving criminal sexual assault. She indicated that the public had not seen any media coverage or information from the Council or Mayor concerning an investigation, and because of the severity of this issue they are concerned about their safety. Ms Ammons urged the Council to look into this matter and keep the public informed.

Cameron Belk, Sr., 1403 E. Washington, addressed the Council in opposition to Ordinance No. 2005-08-121, "An Ordinance Amending Schedule J of Section 23-183 of the Urbana Local Traffic Code Prohibiting Parking at All Times on Certain Streets (Lierman Avenue)."

G. REPORTS OF OFFICERS

Mr. Gray gave an update on the tire collection project that took place on July 9, 2005 for the cities of Urbana, Champaign, and Savoy. They had 123 participants and collected 7,310 tires representing a total of 91 tons. The event was highly successful and the EPA (Environmental Protection Agency) indicated that this doubled the typical number of tires they have received.
