URBANA CITY COUNCIL MEETING September 6, 2005

The City Council of the City of Urbana, Illinois met in regular session at 7:00 p.m., Tuesday, September 6, 2005 in the Urbana City Council Chambers at 400 South Vine Street.

There being a quorum, Mayor Prussing called the meeting to order at 7:18

p.m.

Alderman Roberts moved to approve the minutes of the Special City Council Meeting of August 15, 2005 and the regular meeting of August 15, 2005. The motion was seconded by Alderwoman Barnes and carried by a voice vote.

PETITIONS AND COMMUNICATIONS

John Lee Johnson, 44 E. Main, Champaign, and Burnell Dixon, 507

Crystal Lake Drive, addressed the Council with their concerns regarding the Police

report on racial profiling.

Former Alderman Joseph Whelan presented Fire Chief Rex Mundt with an

award in appreciation for the Departments efforts in assisting Mr. Whelan during a medical emergency and for their fine services at all times.

Mr. Whelan presented Mayor Prussing a \$100.00 check payable to the

American Red Cross for the aid of victims of hurricane Katrina.

Gabe Omo-Osagie, 2419 W. High Cross Road, addressed the Council to

offer free rent for evacuees from New Orleans for two to three months.

Mr. Omo-Osagie also addressed the Council regarding his involvement

with the pedestrian bridge at 122 West Main Street.

Alderwoman Barnes announced that SEUNA (Southeast Urbana Neighborhood Association) will be having a meeting September 14, 2005 at 7:00 p.m. in the Yankee Ridge School Gym.

Alderwoman Chynoweth announced that the Domestic Partner Registry is open and approximately 20 have couples registered.

REPORTS OF STANDING COMMITTEES

Committee of the Whole

Alderman Smyth stated that Ordinance No. 2005-08-125: An Ordinance

Approving and Authorizing the Execution of an Agreement with Gabriel Omo-

Osagie (Pedestrian Bridge) was forwarded to council without recommendation.

Debate followed between the Council and Mr. Omo-Osagie regarding the responsibility for the costs of removing the present pedestrian bridge, rebuilding the bridge, and the maintenance of the bridge after its completion.

Alderwoman Barnes moved to delay action on Ordinance No. 2005-08-

125: An Ordinance Approving and Authorizing the Execution of an Agreement

With Gabriel Omo-Osagie (Pedestrian Bridge) until the Council meeting of

September 19, 2005 and bring it back with something in writing from Mr. Omo-Osagie regarding his intentions concerning the pedestrian bridge. The motion was seconded by Alderwoman Chynoweth.

Following debate, Alderwoman Chynoweth called for a straw vote to direct staff that Council's target is that the owner expends at least \$200,000 of his own funds, excluding grants or loans from the City; that he complete within 24 months a lease for the first floor and that the City over 80% of the cost of the bridge rather than the entire amount. The motion carried by a show of hands of vote

Following debate, the motion to delay action until September 19, 2005 carried by a voice vote.

Alderman Smyth moved to approve <u>Ordinance No. 2005-08-132: An</u> <u>Ordinance Revising the Annual Budget Ordinance (Demolition Costs, K-Mart</u> Site). The motion was seconded by Alderwoman Barnes and carried 7-0 by roll call vote. Voting aye were Members of the Council: Barnes, Bowersox, Chynoweth, Lewis, Roberts, Smyth, and Mayor Prussing – 7; voting nay: none.

Alderman Smyth moved to approve Ordinance No. 2005-08-129: An

Ordinance Amending Schedule H of Section 23-93 of the Urbana Local Traffic

Code Requiring Stop Signs at a Certain Intersection (Lydia Court West at Myra

Ridge Drive). The motion was seconded by Alderwoman Chynoweth and carried 6-0

by roll call vote. Voting aye were Members of the Council: Barnes, Bowersox,

Chynoweth, Lewis, Roberts, and Smyth – 6; voting nay: none.

Alderman Smyth moved to approve Ordinance No. 2005-08-130: An

Ordinance Amending Schedule L of Section 23-187 of the Urbana Local Traffic

Code Prohibiting Parking in Specified Places (Romine Street at Hill Street). The

motion was seconded by Alderwoman Chynoweth and carried 6-0 by roll call vote.

Voting aye were Members of the Council: Barnes, Bowersox, Chynoweth, Lewis,

Roberts, and Smyth – 6; voting nay: none.

REPORTS OF OFFICERS

Fire Chief Rex Mundt reported that the Champaign Fire Department will be sending members to New Orleans in the first phase of the Governor's aide to hurricane Katrina's victims. The Urbana Fire Department will send members as a part of the next phase. At minimum that would be an officer and three firefighters. Mr. Walden presented the report on Economic Development for the month.

NEW BUSINESS

Planner Matt Wempe presented staff report on <u>Ordinance No. 2005-09-</u> <u>135: An Ordinance Approving a Special Use Permit (Request to establish an</u> <u>accessory parking lot within 600 feet of the R-1, R-2, or R-3 Zoning District – Plan</u> <u>Case No. 1949-SU-05)</u>.

Canaan Baptist Church has requested a special use permit for a 16-space accessory parking lot at 306 W. Locust. The necessary permits were not obtained when the lot was built in 2001 and the lot currently does not meet the requirements of the Urbana Zoning Ordinance. The church has worked with the City to bring the lot into compliance, which now includes the requirement to obtain a special use permit.

Following debate, Alderwoman Barnes moved to approve Ordinance No.

2005-09-135: An Ordinance Approving a Special Use Permit (Request to establish an accessory parking lot within 600 feet of the R-1, R-2, or R-3 Zoning District – Plan Case No. 1949-SU-05). The motion was seconded by Alderwoman Chynoweth

and carried 6-0 by roll call vote. Voting aye were Members of the Council: Barnes, Bowersox, Chynoweth, Lewis, Roberts, and Smyth – 6; voting nay: none.

Alderwoman Chynoweth moved to approve the ordinance. The motion

was seconded by Alderman Bowersox and carried 6-0 by roll call vote. Voting aye were

Members of the Council: Barnes, Bowersox, Chynoweth, Lewis, Roberts, and Smyth -

6; voting nay: none.

Police Chief Adair and Assistant Police Chief Bily presented additional information regarding the **IDOT Report on Traffic Stop Data** as requested by the City Council.
