

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 23-93 OF THE URBANA
LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT A CERTAIN INTERSECTION

(Michigan Avenue at Smith Road; Rainbow View at Smith Road; Country Squire Drive at Smith Road; Lantern Hill Drive at Smith Road; Marc Trail at Myra Ridge Drive; Memory Lane at Myra Ridge Drive; Willard Street at Lynn Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,
as follows:

Section 1. That Schedule H of Section 23-93, entitled "Stop Signs Pursuant to Section 23-93", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following intersections where drivers of vehicles shall be required to stop before entering the intersections:

Michigan Avenue	Eastbound	at Smith Road
Michigan Avenue	Westbound	at Smith Road
Rainbow View	Eastbound	at Smith Road
Rainbow View	Westbound	at Smith Road
Country Squire Drive	Eastbound	at Smith Road
Lantern Hill Drive	Eastbound	at Smith Road
Marc Trail	Eastbound	at Myra Ridge Drive
Memory Lane	Westbound	at Myra Ridge Drive
Willard Street	Westbound	at Lynn Street

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in

pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.

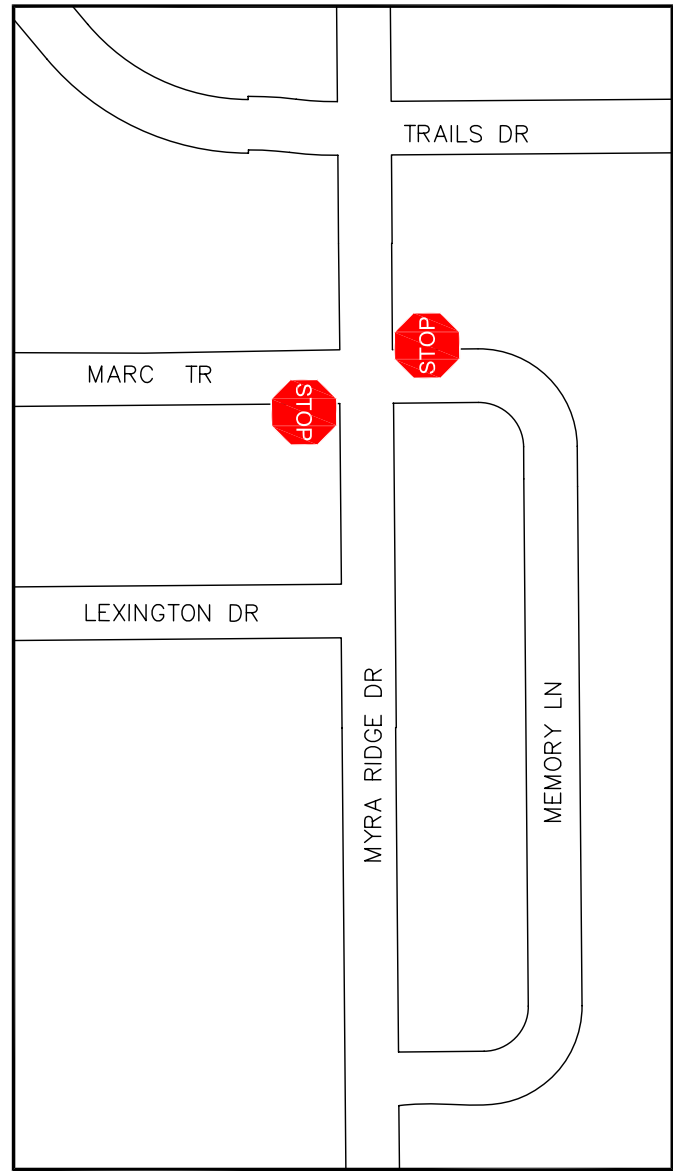
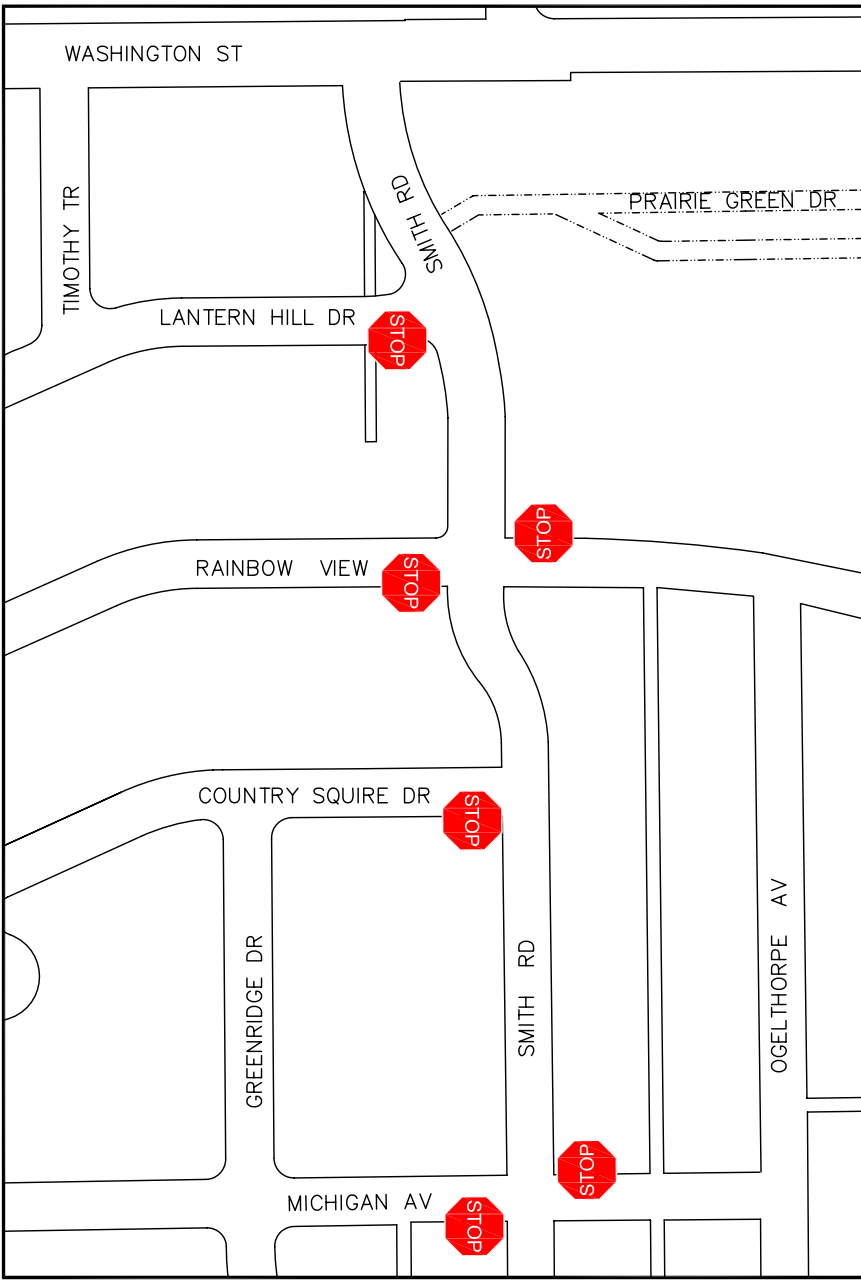

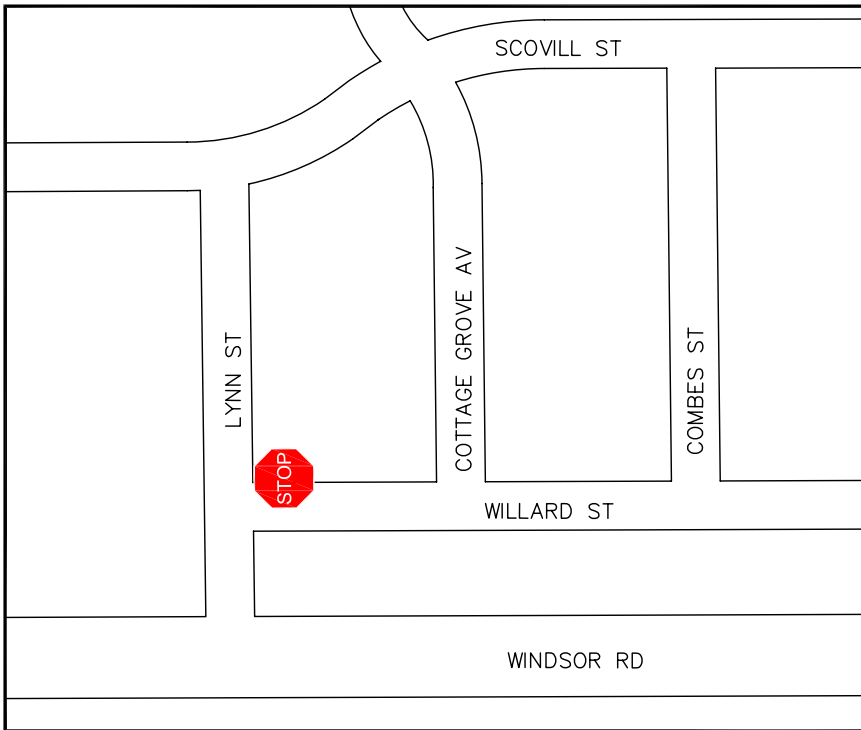
