RE: Ordinances from Traffic Commission

The first ordinance (Schedule J) is a request to install loading zones on Main Street and Lincoln Avenue. The St. Patrick's Church Food Pantry has requested the loading zone to accommodate those who receive food from the food pantry. The loading zone on the north side of Main Street provides the most accessible route from the parish hall to vehicles receiving food from the food pantry. This 15-minute loading zone will be in effect from 4:30 p.m. to 5:30 p.m., Monday through Saturday while the food pantry is open. In addition, loading zones are being requested on the west side of Lincoln Avenue near the commercial area south of Nevada Street and on the east side of Lincoln Avenue near the dormitory residences. Both of these 30-minute loading zones will provide an area for commercial vehicles to load and unload outside the flow of traffic.

The second ordinance (Schedule J) is a request to restrict parking on the north side of Michigan Avenue between Abercorn Street and Montgomery Street. This restriction will comply with the design of the Savannah Green subdivision to allow parking on one side of the street.

The Traffic Commission has considered these locations at its September 2006 meeting and recommends that the ordinance be passed by the City Council.

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-172 OF THE URBANA LOCAL TRAFFIC CODE ESTABLISHING CURB LOADING ZONES ON CERTAIN STREETS

(902 West Main Street, 904 West Main Street, 700 block of South Lincoln Avenue, 800 block of South Lincoln Avenue)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-172, entitled "Standing in Curb Loading Zones" of Article XIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street which shall be established as a loading zone on the designated days or times:

Lincoln Avenue from 330'south the centerline of Nevada Street to 105' south of the centerline of Michigan Avenue	East	All Days Commercia Vehicles Only	al	30 minutes
Lincoln Avenue from the centerline of Nevada Street to 185' south of the centerline of Nevada Street	West	All Days Commercia Vehicles Only	al	30 minutes


Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in
pamphlet form by authority of the corporate authorities, and this Ordinance
shall be in full force and effect from and after its passage and publication
in accordance with Section 1-2-4 of the Illinois Municipal Code.



PROPOSED LOADING ZONE - MAIN STREET

From 75' west of Coler Avenue centerline to 170' west of Coler Avenue centerline, north side of street. Monday - Saturday 4:30 p.m. to 5:30 p.m., 15 minute duration.



PROPOSED LOADING ZONE - LINCOLN AVENUE

From 330' south of Nevada Street centerline to 105' south of Michigan Avenue centerline, east side of street and from Nevada Street centerline to 185' south of Nevada Street centerline, west side of street. All days, commercial vehicles only, 30 minute duration.
