



URBANA CITY COUNCIL SPECIAL MEETING January 8, 2007

The City Council of the City of Urbana, Illinois met in special session at 7:00 p.m., Monday, January 8, 2007, in the Urbana City Council Chambers at 400 South Vine Street.

There being a quorum, Mayor Prussing called the meeting to order at 7:14 p.m.

Present at the meeting were Members of the Council: Barnes, Bowersox, Chynoweth, Lewis, Roberts, and Smyth – 6; absent: Stevenson – 1.

The motion was seconded by Alderwoman Chynoweth and carried 6-0 by roll call vote.

Southwest of Interstate 74 / Ivanhoe Estates).

Following debate, Alderwoman Barnes moved to defeat the Resolution 2007-01-001R: A Resolution of Protest Against a Proposed Map Amendment to the Champaign County Map (A 19 Acre Tract of Land on the North Side of Perkins Road Southwest of Interstate 74 / Ivanhoe Estates). The motion was seconded by Alderman Lewis. Following debate, the motion carried 7-0 by roll call vote. Voting aye were Members of the Council: Barnes, Bowersox, Chynoweth, Lewis, Roberts, Smyth, and Mayor Prussing – 7. Voting nay: none.

Alderman Smyth moved to direct staff to draft a memo to the County

Board expressing the support of the Urbana City Council and Mayor for completion of sidewalks and additional fire hydrants as per the City's own development code. The motion was seconded by Alderwoman Chynoweth. Following debate, the motion carried by a voice vote.
