# URBANA CITY COUNCIL MEETING JANUARY 16, 2007

The City Council of the City of Urbana, Illinois, met in regular session Tuesday\*, January 16, 2007 in the Council Chambers at the Urbana City Building. [\*Monday, January 15, 2007 was a National Holiday (Dr. Martin Luther King, Jr.), therefore, meeting held on Tuesday.]

#### A. CALL TO ORDER AND ROLL CALL

There being a quorum, Mayor Prussing called the meeting of the Urbana City Council to order at 7:02 p.m. [Note: The record recognizes Alderwoman Barnes present via teleconference.]

#### B. APPROVAL OF MINUTES OF PREVIOUS MEETING

Alderwoman Stevenson made a motion to approve the minutes of the regular meeting held December 4, 2006 and the special meetings held December 11, 2006, December 20, 2006, and January 8, 2007. Alderman Lewis seconded.

Mayor Prussing requested that the minutes of the December 4, 2006 meeting recognize her as being absent. There were no objections.

#### E. OLD BUSINESS

1. Ordinance No. 2006-08-109: An Ordinance to Establish a Rental Registration Program for Residential Property Within the City of Urbana

Elizabeth Tyler (Community Development Director/City Planner) presented the staff report.

Alderman Smyth made a motion to approve. Alderman Lewis seconded.

James Gitz (City Attorney) addressed amendments to the ordinance. The first amendment, addressed as Amendment No. 3, consists of the following amendments: [Note: Amendment Nos. 1 & 2 are already incorporated into the ordinance.]

#### 1. <u>Section 3</u>. **Definitions**:

"<u>Rental Agreement</u> means all agreements, written or oral, and rules and regulations embodying the terms and conditions concerning the use and enjoyment of rented premises. It shall also include subleases."

#### 2. Section 10. Assignment of Classifications:

CLASS F - Building is not in compliance with the Rental registration Program and may not be occupied for rental. Violations leading to a Class F designation are violations: (1) which render the unit unsuitable for habitation according to the City's Health, Life, Safety and/or Property Maintenance Codes after notification and reasonable opportunity to remedy such violations; (2) repeated and willful violation of the City's zoning code, including, but not limited to, occupancy requirements; or (3) use of the unit for a criminal purpose, as demonstrated by adjudication of the owner or a tenant for the manufacture, distribution or sale of drugs as set forth and defined by the Illinois Criminal Code. The Class "F" designation shall be withdrawn when the underlying violation has been remedied, or in the case of subsection 3, there has been a change of ownership in the unit, the subject tenant has been evicted, and/or the owner has taken appropriate steps to prevent the unit from constituting a continuing threat to the public."

#### 3. Section 12. Local Agent Required:

"The owner of any rental unit covered by this ordinance shall be available to respond to an emergency on a 24 hour per day basis. This requirement may be met by maintaining an operating business or owner residence within sixty (60) miles of the rental unit, or by use of a local agent who resides within Champaign County or an adjoining county, either of whom can be contacted on a 24 hour per day basis. If a local agent is used, the owner shall provide the City with the name, address, and telephone number of the local agent in addition to owner information. A post office box, mailing address, or long distance 800 numbers shall not be deemed sufficient to meet the provisions of this section."

4. <u>Section 13</u>. **Safety and Security**, amend subsection b) by inserting at the end of the first sentence, the additional phrase "with the exception of owner-occupied rental units which are exempt from this provision."

#### 5. Section 15. Violations:

"(b) The Building Official may refuse to register or revoke the existing registration of any Rental Property which falls within the provisions set forth as a basis of the Class "F" designation set forth in Section 10. In the event that the Building Official denies or revokes registration of a Rental Property, the tenants of the subject property shall be informed Urbana City Council Minutes: January 16, 2007 Page 4 of 9

> by the City of the decision and of their need to obtain other housing. An owner, or the Agent of the owner, may appeal a registration denial or revocation according to the provisions of Section 18."

Alderman Smyth moved to approve Amendment No. 3. Alderwoman Barnes seconded. The motion carried by voice vote.

Mr. Gitz presented Amendment No. 4, consisting of the following amendments:

 <u>Section 3</u>. Definitions, add a new sentence at the end of the definition of "Owner", to read:

"The term shall not include a lessee who previously occupied a rental unit and who is subleasing the unit for the remaining part of his or her lease."

- Section 2. Scope, in first sentence delete the word "their" and insert the word "its".
- 3. <u>Section 4</u>. **Registration of Rental Property**, in the first sentence of subsection c) insert the words "may be" in front of the word "revoked" by the Building Official, and delete the word "provides" and insert "provide" in front of the phrase "an opportunity to appeal the decision pursuant to Section 18 of this Ordinance."
- 4. <u>Section 9</u>. **Inspections**, in subsection c)(1) delete the word "units" and insert "unit" in the sentence "in such notice, the tenants may be addressed as 'occupants' and one such notice mailed to the address of the rental unit, shall be regarded as notice to all tenants."
- 5. <u>Section 15</u>. Violations, in subsection b) insert the word "may" in front of the word "revoke" in the first sentence.

Alderman Smyth moved to approve Amendment No. 4. Alderman Bowersox seconded. The motion carried by voice vote.
