- **RE:** Ordinance from Traffic Commission

Attached is an ordinance for your approval from action taken by the Urbana Traffic Commission.

The ordinance (Schedule J) prohibits parking at all times on Race Street. The location is on the east side of Race Street, south of Florida Avenue. This parking restriction is being requested by a resident who noticed that vehicles parked along the street were constricting the flow of traffic at the intersection of Race Street and Florida Avenue.

The field investigation found that the existing left turn bay length was substandard. As a result of this investigation, the Traffic Commission is also recommending that the turn bay length be increased by fifty (50) feet to bring it to current City standards. This increase in the length requires the extension of the parking restriction. With this parking restriction, traffic will have adequate room to queue in the left turn lane on Race Street at Florida Avenue without crossing the center line.

The Traffic Commission has considered this location at its April 2007 meeting and recommends that the ordinance be passed by the City Council.

ORDINANCE NO. 2007-04-035

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Race Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

Street	Between	Side	of Street
Race Street	From 196 feet south of the centerline of Florida Avenue to 260 feet south of the centerline of Florida Avenue	East	Side

<u>Section 2</u>. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance. Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.


