RE: Ordinance from Traffic Commission

Attached is an ordinance for your approval from action taken by the Urbana Traffic Commission.

The ordinance (Schedule J) prohibits parking at all times on Guardian Drive and Butzow Drive. The locations are on the east and west sides of Guardian Drive, north of Butzow Drive, and north and south sides of Butzow Drive, east and west of Guardian Drive. The parking restrictions are being requested by a resident who noticed that vehicles parked along the street were constricting the flow and visibility of traffic at the intersection of Guardian Drive and Butzow Drive.

The field investigation found that vehicles were parking too close to the intersection, which created a visibility concern for motorists approaching the intersection from the north leg of Guardian Drive and both legs of Butzow Drive. Parked vehicles on Butzow Drive, reduced the lane width for motorists as they approached the intersection from the east. A representative from the Guardian West plant has been contacted and supported this proposed action.

The Traffic Commission has considered this location at its November 2007 meeting and recommends that the ordinance be passed by the City Council.

ORDINANCE NO. 2007-12-137

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Guardian Drive; Butzow Drive)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

<u>Street</u>	<u>Between</u>	Side of Street
Guardian Drive	From the centerline of Butzow Drive to 125 feet north of the centerline of Butzow Drive.	Both Sides
Butzow Drive	From the centerline of Guardian Drive to 200 feet west of the centerline of Guardian Drive.	Both Sides
Butzow Drive	From the centerline of Guardian Drive to 150 feet east of the centerline of Guardian Drive.	Both Sides

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the

effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.
