Ron O'Neal, Jr. (Acting City Attorney) presented staff report. Ms. Barnes made a motion to send to Council for approval. Mr. Smyth seconded. Motion carried by voice vote.

9. Motion to Approve Joining the Sister City Program to Establish a Sister City Relationship with the City of Zomba, Malawi, Africa

Liz Davis (Executive Staff Assistant) presented staff report. Mr. Roberts read emails from Ezekiel Kalipeni, Carl Altstetter, W. David Kay and Jim Locher supporting the establishment of a relationship with the City of Zomba.

After discussion, the Committee recommended that the following action be initiated: joining the Sister City Program; drafting a plan; clarifying the partnership; initiating a meeting with the Zomba community; and making a final offer to Zomba. The Committee would like to see this program integrated among other established entities within the Urbana community. Mr. Roberts agreed to oversee the establishment of this partnership. Mr. Roberts made a motion to approve recommendations. Mr. Smyth seconded. Motion carried by voice vote.

10. Mayors Report

Mayor Prussing recently attended the U.S. Conference of Mayors and reported sustainability is a large concern for cities especially regarding issues with funding. She stated citizens need to start lobbying their congressional delegation regarding this issue. There was some discussion at the conference of charging emission fees or a carbon tax to help control carbon dioxide growth. Code enforcement will also be critical. The Mayor announced there would be a forum held this Wednesday, February 27, 2008 at 7:00 p.m. in the Council Chambers regarding sustainability.

Urbana has been cited in a recent issue of "Illinois Municipal League" for its thirty years as a Tree City USA.

Illinois American Water has proposed a 60% rate increase. The Mayor feels it is important to study all options at this time including possible purchase. The proposed increase does not include the costs of the new plant west of Champaign. Illinois American Water is requesting to have rate increases every two years. The City of Urbana will be splitting costs with several other communities to protest this increase with the Illinois Commerce Commission.

AmerenIP has also proposed rate increases which will impact Urbana greatly. The City is talking with other communities about joining together to protest with the Illinois Commerce Commission. The Council will be presented a resolution in near future to allow the Mayor to enter to intergovernmental agreements with other cities to intervene.

These rate increases have direct impact on economic growth and sustainability.

11. Adjournment

There being no further business to come before the Committee, Chair Chynoweth declared the meeting adjourned at 9:21 p.m.
