Mayor Prussing announced she had received many emails regarding the proposed ban of cell phone usage while driving.

A straw poll showed the Committee divided pretty evenly between wanting hands-on/hands-free ban versus only a hands-on ban.

After discussion, a motion was made by Mr. Smyth to direct staff to review and revise proposed ordinance as discussed, especially as it relates to business and emergency vehicle usage; hands-on or hands-free devices, pedestrian usage, education and enforcement. Mr. Lewis seconded. The motion carried by a voice vote.
