The special census is underway in Southeast Urbana as well as other locations throughout the City. Mr. Carrino also announced there were no new developments in regards to the Gateway Shops.

Mayor Prussing related the current financial standing of the City's birthday celebrations. The Mayor also announced she had just attended the U.S. Conference of Mayors Water Council. She shared the cost of bottled water in Urbana is much higher when compared to regular tap water. It was recommended to use tap water instead of bottled water to avoid the cost and to save on recycling of bottles.

Elizabeth Tyler (Community Development Director/City Planner) announced the Cunningham Beautification Concept Plan would be presented to the public on May $12^{\rm th}$ from 11:30 a.m. to 1:00 p.m. at the Eastland Suites. The public is welcome to attend.

She also announced the American Planning Association is reviewing contestants for the next designations of great neighborhoods. West Urbana was a winner in last year's listing.
