Mr. Smyth moved to send this item to Council for discussion. Mr. Roberts seconded. The motion carried by voice vote.

15. BUDGET MARK-UP

 ${\tt Mr.}$ Roberts made a motion to send the budget to Council. ${\tt Mr.}$ Lewis seconded.

Ms Chynoweth presented a series of motions to support funding for the Public Arts Program. Her reference for discussion was taken from the Public Arts Fund Summary on page 125 of the Budget.

Motion #1: Ms Chynoweth made a motion to move \$8,000 from the UPTV Revenue line item to the Public Arts Expenses line item. Mr. Smyth seconded. Debate ensued.

Chair Bowersox called for the vote by a show of hands. By a show of hands, the vote was as follows:

Aye: Smyth, Chynoweth, Bowersox

Nay: Lewis, Roberts, Stevenson

The motion failed by a show of hands (3-aye:3-nay).

Motion #2: Ms Chynoweth moved to change TIF Funds Transfer from \$60,170\$ to \$104,170. Mr. Smyth seconded. Debate ensued.

Chair Bowersox called for a vote by a show of hands. By a show of hands, the vote was as follows:

The motion carried by a show of hands (4-aye:1-nay). Mr. Roberts did not vote.

Motion #3: Ms Chynoweth moved to transfer \$1,500 from TIF Funds to Public Arts Project for supplies and printing expenditures. Mr. Smyth seconded. Debate ensued.

Chair Bowersox called for a vote by a show of hands. By a show of hands, the vote was as follows:

Aye: Smyth, Chynoweth, Lewis, Bowersox, Roberts

Nay: None

The motion carried by a show of hands (5-aye:0-nay). Ms Stevenson did not vote.

Motion #4: Ms Chynoweth moved to have the Public Arts Project line item changed to reflect the transfer of \$42,000 from TIF Funds to Public Arts. Chair Bowersox seconded for the purpose of discussion. Debate ensued.

Ms Chynoweth withdrew her motion.

Motion #5: Ms Chynoweth moved to transfer the \$5,000 from the UBA (Urbana Business Association) Arts Festival to Public Arts, and remove Gallery Rent Subsidy line item back into Economic Development, bringing Public Arts up to \$76,000 from \$50,000. Mr. Smyth seconded. Debate ensued.

Ms Chynoweth withdrew this motion, replacing it with a motion for the Public Arts Project line item to be increased to \$87,670. [Public Arts \$50,000 + TIF \$42,670 - UBA \$5,000 = \$87,670.] Due to an audio problem, it was not clear who seconded the motion.

Chair Bowersox called for a vote by a show of hands. By a show of hands, the vote was as follows:

Aye: Chynoweth, Bowersox

Nay: Roberts, Stevenson

The motion failed by a show of hands (2-aye:2-nay). Messrs Smyth and Lewis did not vote.
