### ORDINANCE NO. <u>2008-07-079</u>

## AN ORDINANCE AMENDING SCHEDULE N OF SECTION 23-193 OF THE URBANA LOCAL TRAFFIC CODE LIMITING PARKING TIME ON CERTAIN STREETS OR PUBLIC PARKING LOTS

#### (Springfield Avenue)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule N of Section 23-193, entitled "Parking Time Limits Pursuant to Section 23-193", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following streets where no person shall park a vehicle for a period of time in excess of that indicated between the hours specified below on the designated days and times:

Street	Side of Street	Days	Hours	<u>Time Limit</u>
Springfield Avenue from 27 feet west of the centerline of Birch Street to 65 feet west of the centerline of Birch Street	North	Monday through Friday	8:00 AM to 5:00 PM	2 Hours

<u>Section 2.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

<u>Section 3.</u> This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

<u>Section 4.</u> The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in

accordance with Section 1-2-4 of the Illinois Municipal Code.
