Mayor Prussing read a proclamation announcing October 8, 2008 as International Walk to School Day and encourages everyone to consider the safety and health of children today and everyday. Mayor Prussing presented the proclamation to Cynthia Hoyle local coordinator.

Alderman Lewis gave thanks to the Public Works Department and William Gray (Public Works Director)for the work done on Harvey Street which included a sidewalk not considered in the original design.

Thomas Carrino (Economic Development Manager) gave an updated economic development report to the Council. He mentioned several businesses which have recently opened. He also stated that Common Ground Food Co-op has been named the Small Business of the Year award by the

Champaign County Chamber of Commerce. Sunnycrest Mall is undergoing a face-lift due to aggressive efforts of Alderwoman Barnes.

He also mentioned that the special census official results are in and it reflects an increase in population of 3,188 people since the 2000 census. The State recognizes the official population of Urbana as 40,550. He stated the increased revenues from the census have already been incorporated into the budget.

Alderman Roberts announced the Urbana 175<sup>th</sup> Birthday Anniversary float has appeared in two events this year, Fourth of July parade and Labor Day parade. It did win an award for its design at the Fourth of July parade. There will be one last opportunity to view the float during University of Illinois Homecoming parade October 10, 2008 at 6:00 p.m.

Alderwoman Barnes invited the public to the Economic Development Corporation's annual meeting which is October 28, 2008 at 11:30 a.m. at the Colony Club in the stadium.

Mayor Prussing announced there was a dedication of Weaver Park and was awarded Project of the Year from the American Public Works Association for the State of Illinois.

Alderman Gehrig announced a public ceremony was held at the Assembly Hall a week ago for the deployment of the  $33^{\rm rd}$  Brigade Combat Team which is based in Urbana. He wanted to extend best wishes to the soldiers.

Elizabeth Tyler (Community Development Director/City Planner) announced a rescheduling of the University Avenue/Springfield-White Corridor Studies to November 5, 2008 at 6:00 p.m. at the Illinois Terminal.

William Gray (Public Works Director) stated that the Downtown Parking Study results will be shared with the public on October 15, 2008 from 3-5 p.m. at the Urbana Civic Center. Alderman Bowersox asked that the Urbana Business Association be notified of the meeting to help facilitate notification of the meeting.
