#### D. PETITIONS AND COMMUNICATIONS

Erin Bullock, 404 Sunncrest Court West; Beth Parrott, Anna Parrott and Jack Parrott, 406 Sunnycrest Court West; and Emily Svendsen, 407 Sunnycrest Court West presented the Council with a petition signed by residents of the Sunnycrest Court area protesting the recent removal of shrubbery and plantings from the cul-de-sac near their homes. The residents are upset about the possibility of this now becoming a traffic hazard and endangering the lives of the children in the area. They wish all future actions of this nature be addressed with the neighborhoods in advance. William Gray spoke to the group and apologized for the way the clearing was handled. He advised that the Public Works Department would work with the neighborhood in replanting the area and making it better than it was before.

Gary Cziko gave a brief presentation on roundabouts to the Council. He recommends the City use these where possible as they are less costly to maintain after construction and help to eliminate speeding and traffic congestion. Mayor Prussing and members of the Council mentioned areas which have installed roundabouts and their benefits to the public.
