# **Introduction and Background**

The Urbana Park District is requesting the City Council consider the attached petition and ordinance to annex a portion of Judge Webber Park, located at 1701 East Perkins Road. This park is a part of the Urbana Park District system, but is only partially within City limits.

## **Issues and Discussion**

The park is being brought into the City in order to facilitate proper emergency response and to comply with standard Park District practice. Since part of the park is not within the City, emergency responders may not know who should respond to calls from within the park. Judge Webber Park is located on the south side of Perkins Road, east of Brownfield Road. The eastern half of the park is currently within the City. The portion of the park to be annexed is approximately 9.4 acres in area. The park was established in 1985, and is currently leased to an archery club. The park is not open to the public. A community park development for the northern area is planned for the long term. The southern part will become a wet prairie and will be used in the Park District's environmental education programs. To the north of the park are single-family residential areas. To the west is the Urbana Park District's Dog Park, and to the east is the other half of Judge Webber Park. The Sanitary District owns the property south of the park. The Comprehensive Plan designates the future land use for the park as "Parks".

The portion of Judge Webber Park not yet in the City is zoned Champaign County AG-2, Agriculture, and will automatically convert to City AG, Agriculture zoning upon annexation. Parks are permitted by Special Use Permit in the AG district. As a legal non-conforming use, the park would be allowed to remain in operation. City staff anticipates rezoning this park, along with all other Park District properties, to a conservation/recreation zoning district. The City's current CRE, Conservation, Recreation, Education district may be divided into two separate districts for educational/institutional uses and conservation/recreation uses. If this happens, Park District and University properties will be rezoned appropriately.

Since the park is contiguous to the City, it can be immediately annexed without the need for an annexation agreement. Unlike annexation agreements, annexation petitions do not require a separate public hearing. New property taxes will not be generated as a part of this annexation as Park District properties are exempt. City services will not be significantly affected. The annexation will also bring public right-of-way along Perkins Road adjacent to Judge Webber Park into the City. If approved, the annexation would be effective March 12, 2009 at 12:00pm.

## Recommendation

Staff recommends that the Committee of the Whole forward the attached ordinance to the City Council's regular meeting on March 2, 2009 and approve the ordinance to annex Judge Webber Park, located at 1701 East Perkins Road, into the City of Urbana, Illinois effective March 12, 2009 at 12:00P.M.



#### AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF URBANA

#### (1701 East Perkins Road / Urbana Park District)

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and includes certain territory within the Urbana Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on February 10, 2009 that this Ordinance would be voted upon at the regular meeting of this Council at 7:00 p.m., Monday, March 2, 2009; and

WHEREAS, a written petition signed by all of the Owners of Record and at least fifty-one percent (51%) of the electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana; and
