1. CALL TO ORDER AND ROLL CALL

Chair Bowersox called the meeting of the Committee Of The Whole to order at $7:08 \ p.m.$

2. ADDITIONS TO THE AGENDA AND STAFF REPORT

Chair Bowersox noted that he had been informed by the City Clerk that there was an error in the numbers of the ordinances presented in agenda items #8 and #9. 5. PRESENTATION: USE OF "ROUNDABOUTS"

The Honorable James Brainard, Mayor of Carmel, IN, gave a presentation on "Roundabouts". Roundabouts are an alternative to traditional intersections controlled by stop signs or traffic signals. Following his presentation, Mayor Brainard extended an invitation to Mayor Prussing, Council Members and city staff to be his guest for a tour of Carmel and the roundabout sites.

Mayor Prussing and members of the Council expressed gratitude toward Mayor Brainard and the effort he made in coming to Urbana to provide information on roundabouts and how they have benefited his city. They graciously accepted the invitation to visit Carmel, IN.
