# D. PETITIONS AND COMMUNICATIONS

Danielle Chynoweth, 412 W. Illinois; Neil Parthun, 705 E. Colorado, #105; Belden Fields, 206 W. Pennsylvania; Durl Kruse, 2007 S. George Huff all spoke to the Council about their concerns regarding the recent displacement of citizens of the City of Champaign from their living accommodations due to failure of the landlord to pay utilities. They suggested the Council look at enacting an ordinance which addresses a tenant relocation assistance fund and possibly looking at including hotel/motel structures in the rental registration program.

Elizabeth Tyler (Community Development Director/City Planner) told the Council there would be a report for the next Committee meeting on June 8, 2009 regarding an action plan being developed to address the issues of apartment status versus hotel/motel use. She also mentioned there are funds available in the Social Services funding from last year which are slated for emergency relocation.

Mayor Pro-tem Charlie Smyth gave a proclamation from Mayor Prussing to William Gray (Public Works Director) announcing the week of May 17 through May  $23^{\rm rd}$  as being "National Public Works Week in Urbana, Illinois".
