SUBJECT:	Public Hearing for an Annexation Agreement between the City of Urbana and Casey's Retail Company, 2218 E University Avenue		

Due to on-going negotiations between Casey's and adjacent property owners, Casey's request to Champaign County to rezone 2218 E. University Avenue from County R-5, Manufactured Home Park to County B-2, Neighborhood Business has been continued to the June 25, 2009 County Zoning Board of Appeals meeting. Due to this continuation, City staff requests City Council open the public hearing scheduled for May 26, 2009 and then continue it to July 13, 2009.

Below is a revised expected scheduled for this case:

June 25	The County ZBA will hold a public hearing on the amended rezoning application, which requests rezoning to the County's B2 zoning district and will include a Special Use Permit.
July 9	The Urbana Plan Commission will consider a resolution of protest for the amended County rezoning case (rezoning the subject property to the County's B2 zoning district).
July 13	<ul> <li>The City Council will continue the public hearing on the draft annexation agreement.</li> <li>The County's Environment and Land Use Committee will consider the request to Champaign County to rezone the subject property to County B2.</li> </ul>
July 20	The City Council will (1) consider and act on a resolution of protest for Casey's request to Champaign County to rezone the subject property to the County's B2 zoning district and (2) act on the annexation agreement between the City and Casey's.
July 23	The County Board will consider the request to Champaign County to rezone the subject property to County B2.
