#### A. CALL TO ORDER AND ROLL CALL

There being a quorum, Mayor Prussing called the meeting of the Urbana City Council to order at 7:12 p.m.

### B. APPROVAL OF MINUTES OF PREVIOUS MEETING

# b. <u>Motion Approving the Public Arts Program Plan (FY 2009-</u> 2010)

#### c. <u>Social Service Funding/Allocations</u>

Alderman Gehrig and Kelly Hartford (Grants Coordinator) gave the updated staff report. Mayor Prussing suggested adjusting some line items which did not specifically benefit only Urbana residents to help fund the internship program with Urbana Schools. She suggested allotting \$4,000 to fund internships for one public works intern and two fire department interns. She also suggested allotting \$2,085 to the Urbana Park District for summer camp scholarships.

Alderman Smyth made a motion to send this item to the next Committee of the Whole on June 8, 2009 for review. Alderman Lewis seconded. The motion carried by a voice vote.

#### G. REPORTS OF SPECIAL COMMITTEES

There were none.

#### H. REPORTS OF OFFICERS

Mayor Prussing announced she had been notified by Senator Michael Frerichs that Urbana would be getting \$5 million in funding for the Olympian Drive project and \$2.5 million for the Illinois Route 130 project. She also said the Urbana Park District would be receiving \$400,000 in funding as well.

Thomas Carrino (Economic Development Director) gave an overview of the economic development report. New progress included the groundbreaking at Crystal View Townhomes; opening of 901 W. University; dedication of the Chinese Goose plague; Heartland Bank opening; Burger King opening on Philo Road, and the first weekend for Art at the Market with a ceramics workshop.

He also announced there would be a "Builders Spectacular" at Stonecreek from May 30 through June 7, 2009. He mentioned work continues on the Philo Road Beautification project.

Alderman Smyth praised the pedestrian cut-off lighting on Philo Road.

### I. NEW BUSINESS

- 1. Budget Review/Presentations
  - a. Urbana Free Library Debra Lissak (Executive Director) presented the staff report. She mentioned an increase of 7.8% in materials. Future budget implications would be parking, longer operational hours; increasing materials and more programming.

Mayor Prussing turned the chair over to Alderman Smyth at 8:22 p.m.

b. Executive - Mayor Prussing discussed there would be interviewing for the CAO position this year. Otherwise there were no new positions anticipated.

Mayor Prussing returned to the chair at 8:25 p.m.

- c. Finance Ronald Eldridge (Comptroller) announced there were no new personnel or costs anticipated for the next year. He advised the budget was fairly similar to last year. He mentioned some costs would be involved with the broadband proposal which could be addressed later.
- d. City Clerk Phyllis Clark (City Clerk) related the budget costs are 99% contractual. She mentioned a need for a new microfiche reader/printer in the future which could be shared with the police department.

#### 2. Ordinance No. 2009-06-059: An Ordinance Approving the Annual Budget (FY 2009-2010)

Ronald Eldridge (Comptroller) gave the staff report. Discussion followed.

Alderman Smyth made a motion for an amendment to include line items for battery recycling program and rain barrel rebates. Alderwoman Stevenson seconded. The motion carried by a voice vote.

# 4. Ordinance No. 2009-06-057: An Ordinance Amending the Zoning Map of the City of Urbana, Illinois (Rezoning of 714 West California Avenue from R-2, Single-Family Residential, to R-7, University Residential / Plan Case No. 2106-M-09 - Kevin and Julia Webster)

Robert Myers (Planning Manager) gave the staff report with additional information from Elizabeth Tyler (Community Development Director/City Planner) and Ronald O'Neal, Jr. (City Attorney). Kevin and Julia Webster, property owners, spoke to the Council and answered questions.

Alderman Smyth made a motion to vote on the zoning portion of the ordinance and defer the rest until the next Committee of the Whole meeting. The motion died for lack of a second.

Alderman Lewis made a motion to defer to the next Committee of the Whole meeting on June 8, 2009 to allow staff more time to review. Alderman Bowersox seconded. A voice vote was taken, but was inconclusive, so a show of hands was requested by Mayor Prussing with the motion carrying (4-aye:2-nay).
