**RE: Ordinance from Traffic Commission Meeting**

Attached is an ordinance for approval from action taken by the Urbana Traffic Commission.

The ordinance (Schedule J) prohibits parking at all times on the west side of Johnson Avenue between Oregon Street and Illinois Street and on the south side of Hollywood Alley in certain locations between Vine Street and Anderson Street.

Johnson Avenue is a street 25 feet in width between Oregon Street and Illinois Street. The width of the street does not accommodate parking on both sides and two-way traffic. Property owners on that street were notified; two spoke in favor of the restrictions to the Traffic Commission. Restricting parking on the west side of the street is more economical since street light poles on that side of the street can be used for installing the signs.

Hollywood Alley was recently improved to allow off-street parking for residents in that area. The City permitted garages to be placed along the south side of Hollywood Alley in addition to the off-street parking. To provide easier access to the off-street parking and garages, the Traffic Commission is recommending that parking be restricted on the north side of Hollywood Alley across from those areas.

The ordinance (Schedule J) currently prohibits parking on the east side of Glover Avenue in front of the Public Works Center. Since the time that the restrictions were passed, the street has been widened from Washington Street to the northern edge of the property at 706 South Glover Avenue. By rescinding this restriction, visitors will have more spaces for parking and two-way traffic will be able to safely travel along that area.

The Traffic Commission has considered these locations at its August 2009 meeting and recommends that the ordinance be passed by the City Council.

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Johnson Avenue; Hollywood Alley; Glover Avenue)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

<u>Street</u>	<u>Between</u>	<u>Side of Street</u>
Johnson Avenue	From the centerline of Oregon Street to the centerline of Illinois Street	West Side
Hollywood Alley	From 303 feet east of the centerline of Vine Street to 397 feet east of the centerline of Vine Street and 745 feet east of the centerline of Vine Street to 845 feet east of the centerline of Vine Street	North Side

Section 2. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by DELETING from that schedule the following portion of a street where no person shall park a vehicle at any time:

<u>Street</u>	<u>Between</u>	<u>Side of Street</u>
Glover Avenue	From 325 feet north of the centerline of Washington Street to 485 feet north of the centerline of Washington Street	East Side

Section 3. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 4. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 5. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

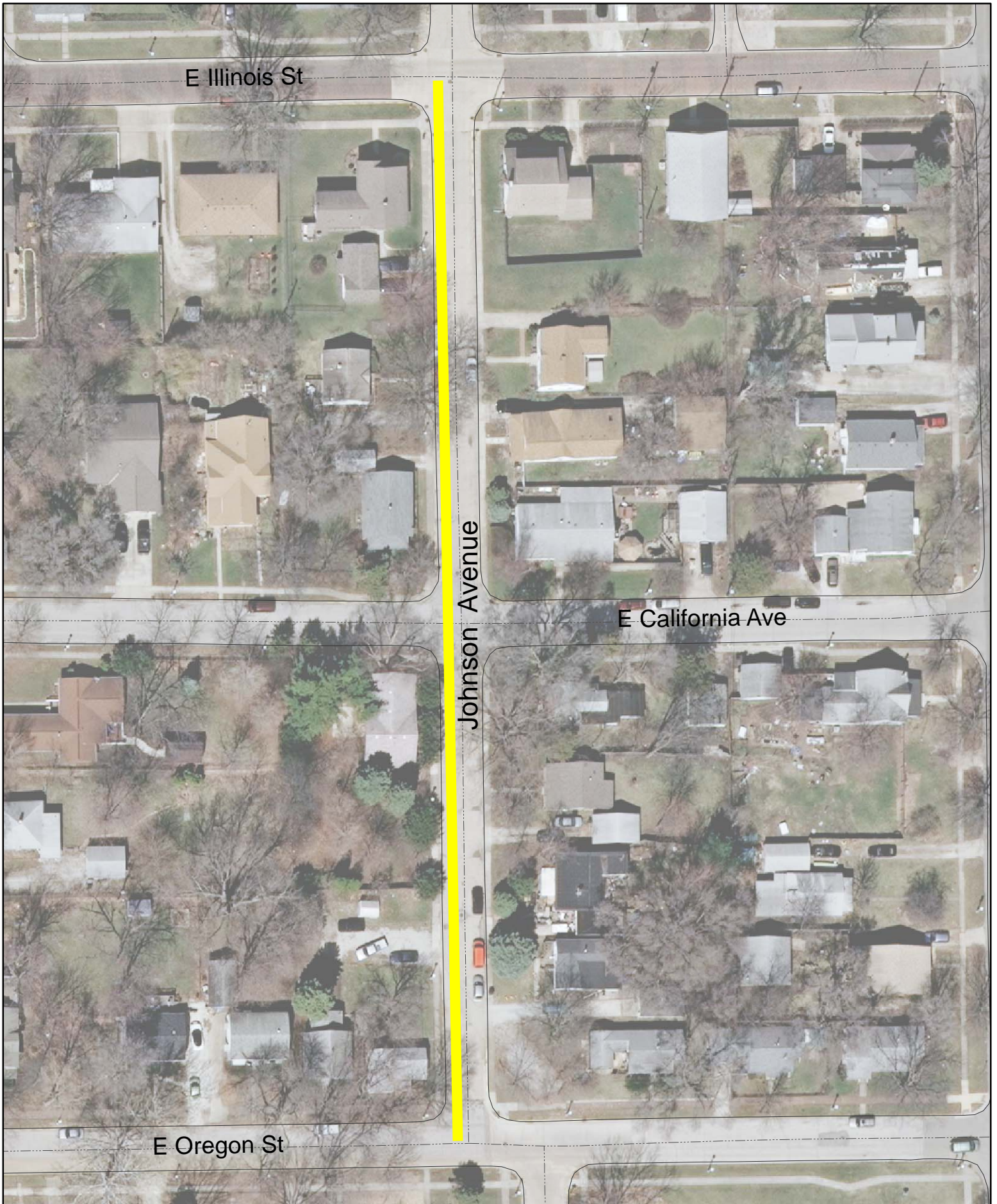

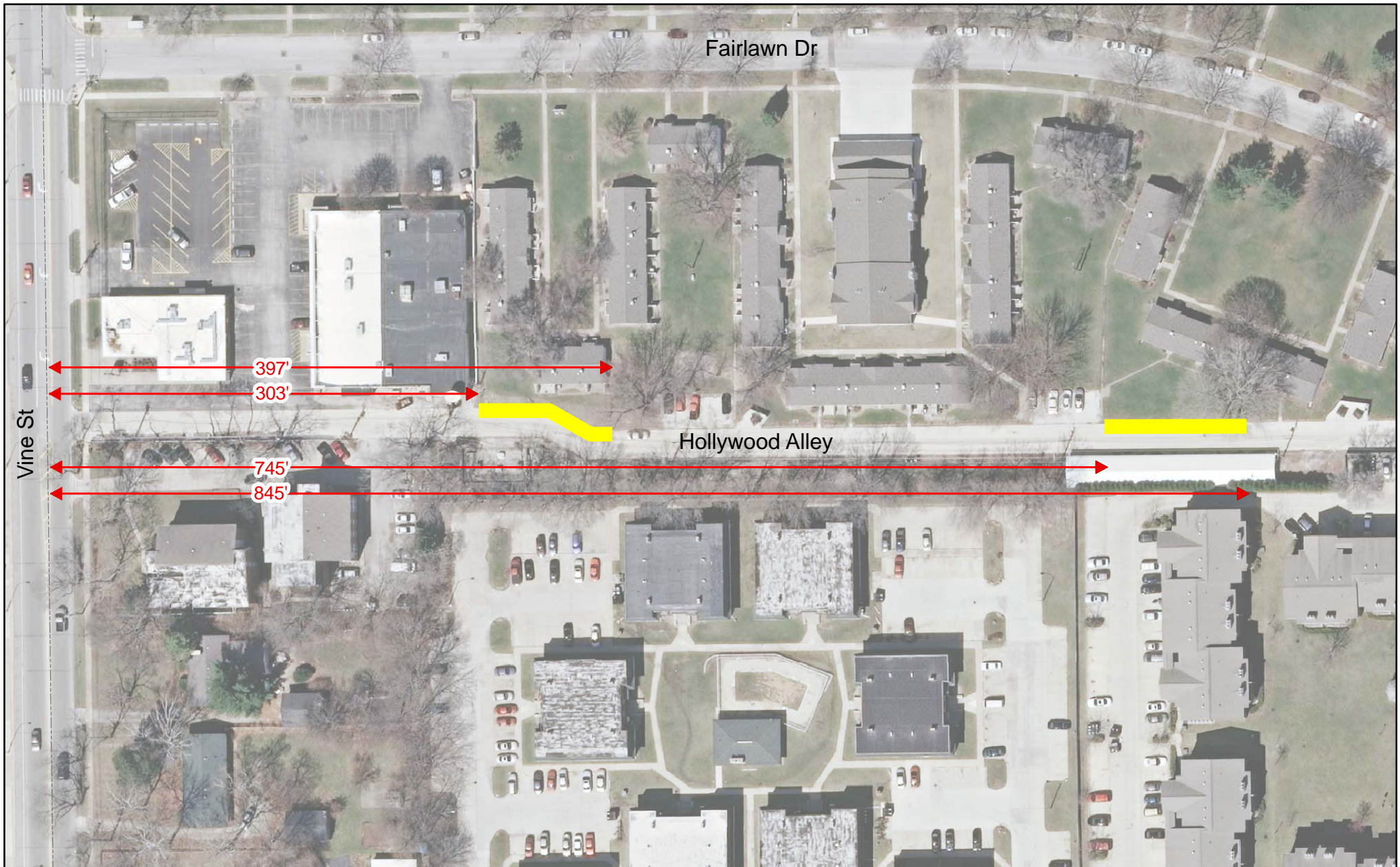


**Proposed No Parking- Johnson Avenue

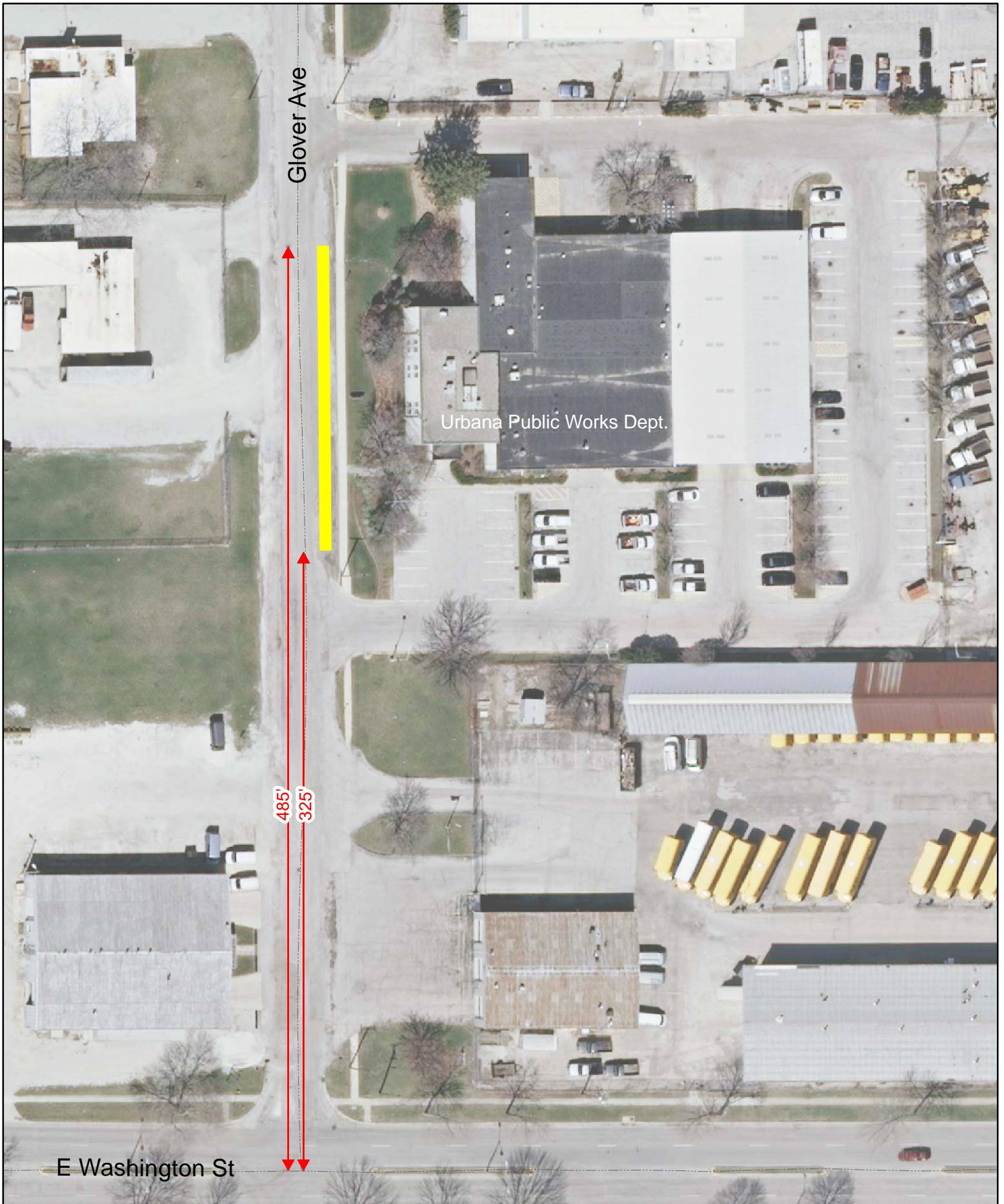


**Proposed No Parking - Hollywood Alley**
