RE: Ordinance from Traffic Commission

Attached is an ordinance for your approval from action taken by the Urbana Traffic Commission.

The ordinance (Schedule J) prohibits parking at all times near the alleys on the east sides of Smith Road, Ogelthorpe Avenue, Montgomery Street and Abercorn Street in the Savannah Green subdivision. These streets are paved streets approximately 24 feet in width that provide access to the residents' garages located in the alley. Currently, these streets prohibit parking at all times on the entire west side. The Savannah Green Homeowners' Association asked for these restrictions to allow better visibility for those exiting the alley onto the streets. The president of the homeowners' association did not indicate that there was a safety concern at the other alley/street intersections.

The Traffic Commission has considered these locations at its September 2009 meeting and recommends that the ordinance be passed by the City Council.

ORDINANCE NO. 2009-09-108

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Smith Road, Ogelthorpe Avenue, Montgomery Street, Abercorn Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

Street	Between	Side	of Street
Smith Road	From 626 feet north of the centerline of Florida Avenue to 706 feet north of the centerline of Florida Avenue	East	Side
Ogelthorpe Avenue	From 660 feet north of the centerline of Florida Avenue to 740 feet north of the centerline of Florida Avenue	East	Side
Ogelthorpe Avenue	From 78 feet north of the centerline of Michigan Avenue to 158 feet north of the centerline of Michigan Avenue	East	Side
Montgomery Street	From 660 feet north of the centerline of Florida Avenue to 740 feet north of the centerline of Florida Avenue	East	Side

Abercorn Street

From 660 feet north of East Side the centerline of Florida Avenue to 740 feet north of the centerline of Florida Avenue

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.



This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
