The new rates will include graduated fines, courtesy tickets for first offense in downtown, increased time frame for payment from 72 hours to 7 days and possible resets every August. The anticipated increase in revenue would be about \$100,000 a year. Staff was asked to look at creating more onstreet rentals in low usage areas in the future and reviewing current agreements with the University and City of Champaign.
