I. NEW BUSINESS

1. Presentation: Rain Garden

William Gray (Public Works Director/City Engineer) introduced his staff, Michael Brunk (City Arborist) and Ray Knight (Landscape Supervisor), who did a brief presentation on rain gardens and one they recently constructed. Mr. Knight's presentation demonstrated the benefits of rain gardens and how they help to rid standing water from going into storm drains.

This item did not warrant Council action at this time.

2. <u>Discussion: Second Floor Relocation Initiative (Retail)</u>

Alderman Roberts presented an initiative for a second floor relocation program for Downtown Urbana retail, that would create a city-based incentive to assist the relocation of non-retail businesses currently located in ground floor business spaces to second floor office space. Debate ensued.

This item did not warrant Council action at this time.

3. <u>Discussion: Creation of a Multi-Use Community Center in Southeast</u> Urbana

Alderman Roberts proposed the creation of a local multi-use community center in Southeast Urbana, based on two neighborhood meetings and a survey of residents in the East Washington Street and South Lierman Avenue neighborhoods (including residents of Scottswood Manor Apartments). Following his presentation, Alderman Roberts gave notice of a public hearing that will be

held November 30, 2009 at 7:00 p.m. in the Urbana City Council Chambers, for the purpose of soliciting public input concerning the creation of a community center serving residents of Urbana.
