7. Ordinance No. 2010-06-049: An Ordinance Amending Chapter 3.5-60 of the Code of Ordinances (Ambulance Response Time Requirements)

Chief Dilley gave the staff report. Discussion followed. Mr. Gehrig made a motion to send this item to Council for approval with language changes. Mr. Lewis seconded. The motion carried by a voice vote.
