8. ORDINANCE NO. 2010-09-080: Ordinance No. 2010-09-080: An Ordinance Designating a Historic Landmark (104 North Central Avenue, "Eli Halberstadt House" / Historic Preservation Case No. HP-2010-L-02)

Robert Myers (Planning Manager) presented the staff report. He stated an official protest had been filed by the property owner, Canaan Baptist Church. Discussion followed.

Committee members asked staff to provide additional information for evaluation to include architectural integrity study of the property; cost of rehabilitation by an independent party; consideration of which entity would pay for the evaluation; review of floodplain and soil conditions in area; consideration of construction options on the site including impact of building restrictions due to liquor store on adjacent property; and possible establishment of a review panel with consideration of members to include church members, staff, and historic preservation members.

Committee members would also like to have more discussions with the public regarding this issue and to review the language in the existing ordinance at a future date to improve the ambiguity and review the process of procedures.

Mr. Roberts made a motion to postpone definitely until the 3rd committee meeting from this date or November 8, 2010 so staff can review and submit additional information for evaluation as discussed. Mr. Bowersox made a friendly amendment to leave the creation and selection of members of the proposed panel to the discretion of Mayor Prussing. There were no objections. Mr. Lewis seconded the motion. The motion carried by a voice vote.

There being no further business to come before the Committee, Chair Smyth declared the meeting adjourned at 10:03 p.m.
