1. Traffic Commission Items:

- b. Ordinance No. 2010-10-091: An Ordinance Amending Schedule J of Section 23-172 of the Urbana Local Traffic Code Establishing Curb Loading Zones on Certain Streets (Harvey Street);
- c. Ordinance No. 2010-10-092: An Ordinance Amending Schedule J of Section 23-183 of the Urbana Local Traffic Code Prohibiting Parking at All Times on Certain Streets (Fairview Avenue);
- d. Ordinance No. 2010-10-094: An Ordinance Amending Schedule M of Section 23-190 of the Urbana Local Traffic Code to Establish Tow Away Zones in Specified Places on Certain Streets (Harvey Street); and
- e. Ordinance No. 2010-10-095: An Ordinance Amending Schedule Q of Section 23-64 of the Urbana Local Traffic Code Decreasing State Speed Limits in Certain Zones (Stebbins Drive, Division Avenue)
