**RE:** Ordinance from Traffic Commission Meeting

Attached is an ordinance for approval from action taken by the Urbana Traffic Commission at its October 5<sup>th</sup> meeting.

The ordinance (Schedule J) would prohibit parking at all times on both sides of Montclair Road at Vine Street, on the north side of Springfield Avenue west of McCullough Street and on the south side of Rainbow View from Ogelthorpe Avenue to Smith Road.

The parking restrictions recommended on Montclair Road will reduce congestion near the stop sign on Montclair Road at Vine Street. Under the current configuration, if vehicles are queued at the stop sign on Montclair Road, vehicles turning westbound from Vine Street onto Montclair Road do not have adequate room to turn onto the street. With this parking restriction, traffic will have adequate room to turn onto Montclair Road from Vine Street and to stop at the stop sign on Montclair Road without causing any reduction in the lanes of traffic.

The ordinance would prohibit parking on the north side of Springfield Avenue from 280 feet to 485 feet west of McCullough Street. The Champaign Urbana Mass Transit District asked for this restriction so they could consolidate their bus stops on Springfield Avenue to a location west of the Phillips Recreation Center. The restriction would allow ingress and egress for two articulated busses.

Finally, the ordinance would prohibit parking on the south side of Rainbow View between Smith Road and Ogelthorpe Avenue. Rainbow View is located between the Savannah Green subdivision and the Prairie Green Apartments. Currently, parking is restricted on the north side of the street. Along the south side of the street in this section, some motorists park in such a manner as to restrict passage of two vehicles travelling on Rainbow View. The restricted traffic lanes necessitate the parking restrictions along Rainbow View between those streets.

The Traffic Commission has considered this location at its October 2010 meeting and recommends that the ordinance be passed by the City Council.

# AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Montclair Road, Springfield Avenue, Rainbow View)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

Street	<u>Between</u>	Side of Street
Montclair Road	From the centerline of Vine Street to 108 feet west of the centerline of Vine Street	Both Sides
Springfield Avenue	From 280 feet west of the centerline of McCullough Street to 485 feet west of the centerline of McCullough Street	North Side
Rainbow View	From the centerline of Smith Road to the centerline of Ogelthorpe Avenue	South Side

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.


Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability

incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.




**Proposed No Parking- Montclair Road** From centerline of Vine Street to 108' west of the centerline of Vine Street - both sides of street.




**Proposed No Parking- Springfield Avenue** From 280' west of McCullough St centerline to 485' west of McCullough St centerline - north side of street.
