A. CALL TO ORDER AND ROLL CALL

Mayor Prussing called the meeting of the Urbana City Council to order at $7:11\ \mathrm{p.m.}$

B. APPROVAL OF MINUTES OF PREVIOUS MEETING

November 15, 2010 - Alderwoman Stevenson made a motion to approve the minutes of the meeting held November 15, 2010. Alderwoman Marlin seconded. There were two corrections called for in the minutes. A correction in section "D" to show Mr. Hill in opposition to wind turbines. Also, in "Council Input", Mr. Smyth asked for a change in language to read "bike lanes will be installed". The motion to approve with corrections carried by voice vote.

C. ADDITIONS TO THE AGENDA

Mayor Prussing asked that item 1A in "New Business" be moved ahead of "Petitions and Communications". She also announced item #6 which was the closed session would be removed from the agenda.

Alderwoman Stevenson made a motion to approve the revised agenda. Alderman Smyth seconded. The motion carried by a voice vote.

Mayor Prussing announced her appointment of Eric Jakobsson to fill the vacant Ward 2 seat created by the resignation of David Gehrig.

Alderwoman Stevenson made a motion to approve. Alderman Bowersox seconded. The motion was approved by a voice vote.

The oath of office was administered to Mr. Jakobsson by Mayor Prussing and Alderman Jakobsson joined the meeting at 7:15 p.m.

D. PETITIONS AND COMMUNICATIONS

Elm, Champaign; Matt Childress, 2203 Aspen Drive; Brian Lilly, 1149 CR 1500 East. Discussion and debate followed.

The following people spoke to the Council regarding their concerns about the wind turbine project and the lack of transparency in public notice and discourse, as well as insufficient studies done on the project: Stephen Platt, 310 Pond Ridge Road; Marcela Raffaelli, 310 Pond Ridge Road; Arne Pearlstein, 209 E. Sherwin Dr.

The following citizens spoke to the Council in opposition to the proposed wind turbine: Doug Wolfersberger, 3212 Chatham; Carl Hill, 1913 Trails Drive.

Carl Hill, 1913 Trails Dr. also spoke of support of the Build Urbana tax rebate.

David Monk, Heartland Pathways, spoke to the Council regarding railbanking and bike trails.

Alderman Roberts announced the City of Urbana in cooperation with the Urbana Sister Cities program went "red" on December 1, 2010 to help raise awareness of World AIDS Day. According to research, between 11 and 17 percent of the Malawi population are living with HIV and AIDS and this has become the leading cause of death in the country. The average life expectancy in Malawi is just 43 years. However in recent

years, increased awareness of the epidemic has led to successful prevention and education programs; the Malawian government and the international community have also implemented treatment plans for those already affected.

Urbana has won a \$15,000 grant to engage the community to learn more about Malawi. Books will be available and read in local schools about Malawi and cooking classes will be held to learn more about the local foods. A mixer is being planned for January.
