#### 1. CALL TO ORDER AND ROLL CALL

Chair Marlin called the meeting of the Committee Of The Whole to order at 7:11 p.m. [Note: Started at this time due to Cunningham Town Board meeting being held prior to.]

#### 2. ADDITIONS TO THE AGENDA AND STAFF REPORT

There were no additions to the agenda.

Elizabeth Tyler (Community Development Services Director/City Planner) informed Committee Members that the C-U Safe Routes to School Project and the Mass Transit District are sponsoring a workshop to be held this Thursday (January 13, 2011) entitled "Walk Your Way to a Healthier Life". This event will be held at the Art Theatre on Church Street in Champaign.

Thomas Carrino (Economic Development Division Manager) reviewed the economic development report that was distributed earlier, noting that the basic packet material was developed with the City's new website design in mind. He also informed the Committee that the results of the new business survey conducted in 2009-2010 has been processed and is available on the City's website.

Mayor Prussing informed Committee Members that the Neighborhood Safety Task Force will be meeting in February to discuss establishing an ordinance on clearing sidewalks when it snows (commercial areas and safe routes to school), and licensing for hotels.

Scott Dossett, 501 E. High St., addressed the Committee regarding the new Sister City, (Zomba Malawi) and extended an invitation to attend an event to be held January 29, 2011 from 4:00 p.m. to 5:45 p.m. in Lewis Auditorium at the Urbana Free Library.

## 5. DISCUSSION: ORDINANCE NO. 2010-09-080, AN ORDINANCE DESIGNATING A HISTORIC LANDMARK (104 NORTH CENTRAL AVENUE, "ELI HALBERSTADT HOUSE"/HISTORIC PRESERVATION CASE NO. HP2010-L-02)

## 6. MOTION DIRECTING STAFF TO PREPARE AN ORDINANCE REQUIRING LICENSED HAULERS SERVING COMMERCIAL PROPERTIES TO PROVIDE RECYCLING SERVICES TO CUSTOMERS

Bart Hagston (Environmental Sustainability Manager) presented the staff report.

Mr. Jakobsson made a motion directing staff to prepare an ordinance related to Option #2 of staff's report. Mr. Lewis seconded.

Mr. Smyth made a friendly amendment to include: 1) the idea of allowing participation in one of the City's two existing programs; 2) review in two years; 3) include a significant education component; and 4) aim to make it mandatory in five years. Messrs. Jakobsson and Lewis accepted. Following debate, the motion carried by voice vote, as amended.

This item was acted on at Committee level and did not require action in Council forum.

Before moving on to the next item of business, Mr. Hagston informed the Committee of an event that is planned to be held in the Spring to do a
