#### H. REPORTS OF OFFICERS

Alderman Roberts announced two members of the Urbana Sister City committee would be attending the Sister Cities International Annual Conference in Arlington, Virginia from March 3<sup>rd</sup> through the 5<sup>th</sup>. He stated that two members from Malawi would be in Urbana for a visit.

Mayor Prussing thanked William Gray, Rich Coyne and the Public Works department for their efforts in maintaining the streets and roads during the winter inclement weather.

William Gray (Public Works Director) announced a meeting of the Champaign County Committee of the Whole at 7:00 p.m. in the County board room on Thursday, February 10, 2011. Discussion will include the Lincoln Avenue/Olympian Drive project.

Elizabeth Tyler (Community Development Director/City Planner) announced on Friday, February 11, 2011 at 11:00 a.m. in the City Building hallway, the City of Urbana and the Museum of the Grand Prairie (formerly the Early American Museum)will hold a public speaking engagement in an effort to set a new Guinness World Record for most simultaneous readings of the same document. As part of the Civil War Sesquicentennial, they will be reading Abraham Lincoln's 1861 "Farewell Address".

Thomas Carrino (Economic Development Manager) gave an updated economic development report. He announced several new tenants in the Gateway Shoppes including a second location for Rainbow Gardens and Great Clips. Jimmy Johns and Pancheros are planning to locate at an out-lot. He also announced expansion of Creative Thermal Solutions and Frasca is working on a simulator project. Carle has started construction of their new Heart and Vascular Center.

He also announced the new Public Arts Coordinator, Christina McClelland. He stated they were reviewing arts grants applications at this time. He also said the current "Artist of the Hallway" was Hua Nian who was exhibiting his pen and ink drawings.
