1. Report: Citizen's Police Review Board (CPRB) Quarterly Report

This event is sponsored in part by the City of Urbana.

7. Discussion: Snow Removal Issues

Mayor Prussing acknowledged public input at this time.

Christina Nelson, 2108 Grange Drive, addressed the Council in support of snow removal on sidewalks.

Alderman Smyth informed Council Members that his concern regarding this issue is for the intersections where there is a lot of pedestrian traffic. He indicated that something should be established that would keep the City's snow plows from burying the sidewalks.

Mayor Prussing informed the Council that this is an item that will be discussed at an upcoming Neighborhood Safety Task Force meeting. Alderman Smyth noted that he had received emails from Dannie Otto regarding this issue mentioning several points of interest, and requested that Mr. Otto be invited to attend the Neighborhood Safety Task Force meeting.
