1. CALL TO ORDER AND ROLL CALL

Some families will have to be relocated with assistance from the relocation funding available through the City.

Mike Monson (Chief of Staff) announced the Champaign County Board will consider intergovernmental agreements for Olympian Drive and Lincoln Avenue at their meeting on April 12, 2011. Final passage of the agreements will then take place at April 21st meeting.

5. Ordinance No. 2011-03-016: An Ordinance Amending Chapter Fourteen of the Code of Ordinances, City of Urbana, Illinois, Regarding the Schedule of Fees (July 1, 2011 through June 30, 2012)

Ronald Eldridge (Comptroller) gave the staff report and reviewed changes for the next year. Discussion followed. Additional information was provided by William Gray (Public Works Director) and Patrick Connolly (Police Chief). Mr. Smyth made a motion to send to Council for approval. Mr. Lewis seconded. The motion carried by a voice vote.

6. Ordinance No. 2011-03-012: An Ordinance Amending Schedule H of Section 23-93 of the Urbana Local Traffic Code Requiring Stop Signs at a Certain Intersection (Coler Avenue at Church Street)

William Gray (Public Works Director) gave the staff report. Mr. Smyth made a motion to send to Council for approval. Mr. Lewis seconded. The motion carried by voice vote.

7. Ordinance No. 2011-03-013: An Ordinance Amending Schedule J of Section 23-183 of the Urbana Local Traffic Code Prohibiting Parking at All Times on Certain Streets (Barr Avenue)

William Gray (Public Works Director) presented the staff report. Ms. Marlin made a motion to send to Council for approval. Mr. Smyth seconded. The motion carried by a voice vote.

8. Ordinance No. 2011-03-014: An Ordinance Revising the Annual Budget Ordinance (Illinois Arts Council Public Art Program Operating Support Grant - 2011)

Thomas Carrino (Economic Development Manager) presented the staff report and announced the City had received a \$1750 grant which Anna Hochhalter had authored. Mr. Smyth made a motion to send to Council for approval. Mr. Jakobsson seconded. The motion carried by a voice vote.

9. Ordinance No. 2011-03-015: An Ordinance Revising the Annual Budget Ordinance (Historic Preservation Grant - 2011)

Robert Myers (Planning Manager) made the staff report. The City has received a \$5908 award to create a "100 Most Significant Structures" list for Urbana which will result in a brochure, map and website. Any structure in Urbana is eligible for consideration. The listing will be honorary and for recognition only. Mr. Smyth made a motion to send to Council for approval. Ms. Marlin seconded. The motion carried by a voice vote.
