H. REPORTS OF OFFICERS

Kelly Hartford (Interim Acting Grants Manager) announced the worksheets were available for review of the Consolidated Social Service Funding and the funding available is estimated between \$306,900 and \$316,900. She said they were adding to the list for emergency relocation funding to replenish what has been used to date. She explained the point of time survey that was given to the Council for review. Presentations by some of the groups requesting funding will be next Monday, April 25, 2011 at 5:30 p.m. in the Council chambers.

William (Public Works Director) presented the new recycling brochure which will be mailed to the residents of Urbana. He stated there were two additional items being recycled now including plastic shopping bags and plastic tubs such as margarine type containers and books. He said the rain barrel and compost bin sale went well. All of the rain barrels sold out and they sold 300 of the compost bins. He also announced five groups had signed up to do clean-up along the roads and highways.
