#### I. NEW BUSINESS

# 1. Ordinance No. 2011-06-046: An Ordinance Approving the Annual Budget (FY 2011-2012)

Ronald Eldridge (Comptroller) provided the staff report. Discussion followed.

Mayor Prussing turned the chair over to Alderman Smyth at 8:53 p.m. to address the Council. Alderman Smyth turned the chair back to Mayor Prussing at 8:55 p.m.

Alderman Smyth made a motion to postpone this item definitely for additional review and action during a Special Council meeting on June 13, 2011. Alderman Roberts seconded. The motion was passed by a voice vote.

#### 2. Discussion: Brick Street Reconstruction, McCullough Street

William Gray (Public Works Director) gave the staff report and reported the street bricks used originally were not regular street bricks and were smaller than normal. Costs to repair and maintain a brick street would be around \$200,000. Costs to replace with a concrete street would be \$70,000. Both types of construction would have a lifespan of about 40 years and would be funded from the motor fuel tax. Discussion followed. Alderman Smyth made a motion to proceed with a concrete reconstruction. Alderman Bowersox seconded. The motion passed by a voice vote.
