## A. CALL TO ORDER AND ROLL CALL

There being a quorum, Mayor Prussing called the meeting of the Urbana City Council to order at 6:00 p.m.

#### H. REPORTS OF OFFICERS

Thomas Carrino (Economic Development Manager) gave an updated Economic Development Report. He mentioned new activity at Gateway Shoppes including Skinni Girl Yogurt and Rainbow Garden Restaurant. He also stated that Po'Boys Restaurant was relocating to the area. A ribbon cutting was held recently for The Studio. A ribbon cutting and open house was held on August  $16^{\rm th}$  at Martin Luther King Jr. Elementary School. Link card usage was very good last weekend at the Market at the Square.

He announced there would be a breakfast and local foods discussion with food systems analyst, Ken Meter of the Crossroads Resource Center, Minneapolis, Minnesota on Saturday, September 10, 2011 at 8:30 a.m. at the Common Ground Food Co-op in Lincoln Square Mall. The public will need to make reservations with Lisa Bralts by September  $8^{\rm th}$ .

Alderman Bowersox announced there was a groundbreaking ceremony for the UC2B Urbana Broadband project at Douglass Park in Champaign. Residents of Urbana can view exhibits and plans of the UC2B Urbana Broadband project at an informal public open house to be held in the Multi-Purpose Room at Martin Luther King, Jr. Elementary School, 1108 West Fairview Avenue, Urbana, Illinois on Wednesday, August 31, 2011 from 4:00 p.m. to 7:00 p.m.

#### I. NEW BUSINESS

1. Ordinance No. 2011-09-107: An Ordinance Revising the Annual Budget Ordinance (Purchase of Street Sweeper)

William Gray (Public Works Director) gave the staff report. The main sweeper will be transitioned to back-up sweeper and the proposed new sweeper will be the main sweeper which is used everyday. The current back-up sweeper is in need of repairs of \$20,000 or more and rental of a sweeper is also not cost effective at \$2500 a month. There are currently funds in the

> Vehicle and Equipment Replacement Fund which could help offset the additional cost of a new sweeper. Discussion followed.

Alderwoman Marlin made a motion to approve. Alderman Jakobsson seconded. The vote was as follows:

Alderman Roberts made a motion to have the item postponed definitely until the next Committee meeting to give Staff time to review possible cost reduction options. Alderman Smyth seconded. The motion carried by a voice vote.

2. Ordinance No. 2011-09-106: An Ordinance Authorizing the Purchase of Certain Real Estate (1007 North Berkley Avenue)

Elizabeth Tyler (Community Development Director/City Planner) gave the staff report. The property was damaged beyond repair by a fire in 2004. The owner did not have the funds to demolish the structure. The owner and mortgage holder agreed to a court ordered demolition by the City. The City has placed a lien on the property for the cost of the demolition of \$8,100. The City has incurred additional costs over time for the upkeep of the property including mowing. Foreclosure on the property was instituted recently to gain clear title. A public sale is scheduled for September 9<sup>th</sup>. The City has spent \$19,174 thus far on the property and should incur about \$610 additional fees with the sale. The City's bid will not exceed \$21,000 and if there should be a higher bid, the City will recoup all losses to date. If City is successful, the property can be used for affordable housing. Alderman Smyth made a motion to approve. Alderman Jakobsson seconded. The vote was as follows:

Robert Myers (Planner) gave the staff report. Staff would like to amend zoning ordinance to create standards for portable storage containers on private and public rights-of-way. The amendment would place a limit on allowed time, location, condition and dimensions of containers. Discussion followed. Council felt that some of the language needed to be reviewed and adjusted by Staff. Alderman Smyth made a motion to postpone definitely to the next Committee meeting. Alderwoman Marlin seconded. The motion carried by a voice vote.

## 3. Mayoral Appointment

Mayor Prussing announced her appointments of Virginia Waaler to the Public Arts Commission and Mary Tompkins to the Plan Commission. Alderman Smyth made a motion to approve the appointments. Alderman Roberts seconded. The motion carried by a voice vote.
