Mike Monson (Chief of Staff) reported on using incentives to motivate health behaviors in employees. He has recently met with Vacellia Clark (Human Resources Manager) to discuss implementation of some of the suggestions.

Mayor Prussing also discussed the recent article in the News Gazette regarding the reduction in crime in SE Urbana and thanked the Police Department for their efforts.
