> Samuel Johnson spoke in favor of the proposed snow removal ordinance and gave an overview of his neighborhood volunteer group.

D. Resolution No. 2011-11-041R: A Resolution Authorizing the Mayor to Execute a Certificate of Consistency for the Housing Authority of Champaign County (Hamilton on the Park - Dunbar Court Redevelopment Project)

IV. Ordinance No. 2011-11-124: An Ordinance Amending the Zoning Ordinance of the City of Urbana, Illinois (Revision to Section VIII-5 Regarding Parking Requirements in the CCD, Campus Commercial District - Plan Case No. 2162-T-11)

Robert Myers (Planning Manager) gave the staff report. The Zoning Administrator is requesting the amendment to revise the minimum number of parking spaces required for multi-family housing in the CCD from 0.75 spaces per bedroom to 0.5 spaces per bedroom. This would bring the parking requirement in line with other residential districts. Discussion followed.
