ORDINANCE NO. 2011-12-138

AN ORDINANCE APPROVING A COLLECTIVE BARGAINING AGREEMENT WITH LOCAL 1147 OF THE INTERNATIONAL ASSOCIATION OF FIRE FIGHTERS

(Term of July 1, 2011, through June 30, 2013)

WHEREAS, Local No. 1147 of the International Association of Fire Fighters ("IAFF") is the authorized bargaining agent for certain fire fighters employed by the City of Urbana; and

WHEREAS, the duly authorized representatives of the City of Urbana in good faith have negotiated a two-year collective bargaining agreement ("Agreement") with IAFF Local No. 1147 concerning wages, hours, terms, and other conditions of employment for the term of July 1, 2011, through June 30, 2013; and

WHEREAS, the Agreement has been lawfully and properly ratified by the membership of IAFF Local No. 1147; and

WHEREAS, the City Council finds that the best interests of the City are served by executing the Agreement.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Urbana, Champaign County, Illinois, as follows:

Section 1.

The collective bargaining agreement between the City of Urbana, Illinois, and IAFF Local No. 1147, in substantially the form of the copy of said Agreement attached hereto and hereby incorporated by reference, be and the same is hereby authorized and approved.

Section 2.

The Mayor of the City of Urbana, Illinois, be and the same is hereby authorized to execute and deliver and the City Clerk of the City of Urbana, Illinois, be and the same is authorized to attest to said execution of said Agreement as so authorized and approved for and on behalf of the City of Urbana, Illinois.

Section 3.

The City Clerk shall transmit a certified copy of this Ordinance to Fred Westhoff, President, IAFF Local No. 1147.

Section 4.

The City Council hereby authorizes disbursement of all necessary retroactive pay as provided in the collective bargaining agreement.
