RE: Ordinance from Traffic Commission

Attached is an ordinance for your approval from action taken by the Traffic Commission.

The ordinance is for the removal of the curb loading zone at the intersection of Oregon Street and Gregory Place. The 30-minute parking meter head was recently replaced with a 2-hour parking meter head due to lack of use. JSM Management was contacted to ask if they still needed the loading zone. Jill Guth from JSM stated that most of their deliveries were received from semi trailer trucks which unloaded from the street. She said that they no longer needed the loading zone.

The Traffic Commission has considered this location at its February 2012 meeting and recommends that the ordinance be approved.

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-172 OF THE URBANA LOCAL TRAFFIC CODE ESTABLISHING CURB LOADING ZONES ON CERTAIN STREETS

(Oregon Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-172, entitled "Standing in Curb Loading Zones" of Article XIII of the Urbana Local Traffic Code, is hereby amended by DELETING from that schedule the following portion of a street which shall be established as a loading zone on the designated days or times:

Side of Street

Days

Hours

Duration

Oregon Street from the South

West right-of-way line of Gregory Place to 50'

West of the west right

-of-way line of Gregory Place

Days

Hours

Duration

At all times 30 minutes

West of the west right

-of-way line of Gregory Place

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.



This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
