RE: Illinois Transportation Enhancement Program Grant Application

Wayfinding and Signage Phase II & III

Introduction

The City of Urbana is applying for an Illinois Transportation Enhancement Program (ITEP) Grant to help fund Wayfinding and Signage Phase II & III as prepared by Selbert Perkins Design Collaborative.

Proposed Improvements

The proposed improvements consist of the installation of vehicular, bicycle, and pedestrian directional signage in the downtown and at key entryways to the city. The downtown directory signs would include touch screens. See the attached Sign Location Plan – Project Area and Family of Sign Types.

Project Purpose

The project will continue with the installation of wayfinding and signage as recommended in the 2012 Downtown Urbana Plan and Downtown Parking Study.

ITEP Grant

The city is seeking 80% funding or \$680,000 in this ITEP federal grant application. The local match (20%) would be \$170,000 for a total project cost of \$850,000. The attached resolution of support approved by the city council is required for this grant application.

Project Status

The preliminary design for this project has not begun and is dependent on grant funding.

Project Timeline

ITEP grant award notification is expect this fall. If successful installation of the signage would not occur until the fall of 2013.

Fiscal Impact

The local share of the project cost in the amount of \$170,000 will be funded using Capital Replacement and Improvement Funds (A09).

Recommendations

It is recommended that A Resolution of Support for Application for Illinois Transportation Enhancement Funds by the City of Urbana (Wayfinding and Signage Phase II & III) be approved.

WHEREAS, the City of Urbana has determined that it is in its best interest to apply for said funding to further extend the City's signage network.



Section 1. The City Council finds and determines that the facts contained in the above recitations are true.


