Closed Session: Property Acquisition Issues, Pursuant to 5 ILCS 120/2(c)(5) Minutes Approved, 9/18/2017; Approved for Release, RES. 2017-08-059R

The City Council of the City of Urbana, Illinois met in regular session Monday July 16, 2012 in the Council Chambers at the Urbana City Building, 400 S. Vine St. There being a quorum, Mayor Prussing called the meeting to order at 7:03pm. In the course of the meeting, a Closed Session was held:

Alderman Smyth made a motion to go into a closed session at 7:17 p.m. to discuss Property Acquisition Issues Pursuant to 5 ILCS 120/2(c)(5), seconded by Alderman Jakobsson. Mr. Burgett and Community Development described the process and negotiations for property for use by Habitat or others to build affordable housing at 1006 N. Wright Street, Urbana. This was the parking lot for the Church of the Redeemer which had folded. The Church is on the Champaign side and through a series of negotiations; the property was split between the cities. The Urbana portion, representing two lots, is \$22,000. Council consented and returned to the main council chambers. (ref: Ordinance 2012-07-074)
