SUBJECT: Motion to Allow Sanitary Sewer Connection for 1501 North Coler Avenue Under

the Urgency Provisions of Resolution No. 9394-R-13

Introduction and Background

Susan and Bertram Bruce, the owners of a single-family home located at 1501 North Coler Avenue, are requesting authorization for an emergency sewer connection to the Urbana-Champaign Sanitary District (UCSD) under the urgency provisions of Resolution No. 9394-R-13 (see Exhibit B). The septic system on the subject property is no longer working, necessitating an emergency connection to the sanitary sewer system.

The subject property is located along Coler Avenue, northwest of the Champaign County Fairgrounds. It is currently adjacent to the corporate limits of Urbana. Under an intergovernmental agreement with the UCSD, any property owner outside the corporate limits of Urbana wishing to connect to sanitary sewer service and annex to the UCSD must also agree to annex to the City of Urbana at such time as their property is contiguous. Since this property is contiguous it may be immediately annexed. However, due to a conflict between the property's current zoning in the county (R-4, Multi-Family Residential) and the Comprehensive Plan future land use designation (Residential – Urban Pattern), an annexation agreement is accompanying the annexation petition in order to rezone the property to City R-2, Single-Family Residential District, upon annexation.

Under the provisions of Resolution 9394-R-13, the City may allow an emergency sewer connection in anticipation of the completion of an annexation. The owners have submitted a signed annexation petition. City Council will be presented with an annexation agreement and petition at an upcoming meeting.

RESOLUTION NO. 9394-R13

A RESOLUTION ESTABLISHING PROCEDURES FOR APPROVAL OF ANNEXATION AGREEMENTS FOR THE PURPOSES OF SANITARY SEWER CONNECTION

WHEREAS, the City of Urbana and the Urbana-Champaign Sanitary District (UCSD) entered into an intergovernmental agreement (UCSD Agreement) which provides that UCSD will not permit persons to connect to its sanitary sewer system unless the property to be served is within the City, within a subdivision approved by the City, or is in an area that is the subject of an annexation or development agreement with the City; and

WHEREAS, UCSD and the City desire to implement the UCSD Agreement without causing unnecessary delay for persons who are willing and able to enter into annexation agreements; and

WHEREAS, the City finds that if a person delivers to the City an irrevocable offer to enter into an annexation or development agreement in the form of an annexation agreement or annexation petition, that UCSD should then be authorized to provide sanitary sewer service to the property under the UCSD Agreement.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

<u>Section 1.</u> An annexation agreement or annexation petition may be presented to the City Council or to a Standing Committee of the Whole City Council for review and approval for the purpose of allowing a UCSD sanitary sewer service connection.

Section 2. If the said annexation agreement or annexation petition is acceptable to the City Council or Standing Committee of the Whole City Council, they shall, by motion, direct City staff to inform the UCSD that the City of Urbana has received an annexation agreement or annexation petition in a form acceptable to the City and that said agreement or petition is considered sufficient to authorize UCSD to provide sanitary sewer service to the property.

Section 3. Nothing in this process shall be construed to preempt the requirements of the Illinois State Statues governing the approval of annexation agreements nor shall this approval prevent the City Council from amending, modifying, supplementing or repealing an annexation agreement.
